## 1. PUBLIC HEARING ON A CONDITIONAL USE

• CASE NO. CU-SPR19-07; 4055 Turner Road SE

**Request:** A conditional use application to add a cannabis concentrate processing operation, classified as a heavy manufacturing use, to an existing marijuana production facility. The subject property is zoned IG (General Industrial), and located at 4055 Turner Road SE (Marion County Assessor map and tax lot number: 082W07B / 02100).

Mr. Brewer read the applicable criteria into the record. No objection to jurisdiction was raised and the public hearing was opened at 5:33 p.m.

Case Manager Brandon Pike entered the staff report, all attachments, and the presentation into the record and proceeded with the presentation.

#### RECOMMENDATION

**Condition 1:** The cannabis concentrate processing shall be performed as described

in the applicant's written statement included as Attachment C.

**Condition 2:** Provide an updated waste management and disposal plan, in

accordance with SRC 74.210.

**Condition 3:** The cannabis processing facility shall utilize an air filtration system to

ensure that odor impacts upon neighboring properties are minimized.
