## FINAL Meeting Minutes - WSNA - 2019-04-15

Jim Allhiser called the meeting to order at 7PM. 15 members signed the attendance roster. EM Easterly moves to approve minutes – second by Linda Bierly. Vote unanimous approval.

Presentation: Our Salem - Eunice Kim - https://www.cityofsalem.net/Pages/our-salem.aspx

What – A multiyear project to update the comprehensive plan. Includes unincorporated areas. All "sub-plans" are consistent with the master plan, such as the Transportation Systems Plan (TSP), Parks Plan, etc. There are 3 phases to the project, we are in Phase 1 right now, coming to a close. An RFP for contractors to assist with the Phase 2 is out right now, hopefully closing and selecting this summer.

Phase 1 – Today – Measuring existing conditions. Salem residents helped identify 20 ways to measure Salem, called indicators. Data modeling and analysis was used to predict what would Salem look like 20 years from today, if few or little changes were made to existing zoning and regulations. Of the 20 indicators measured and forecasted, with a normal population growth model and an aggressive population growth model, most of them did not change such as percentage use of public transit, bicycle and pedestrian use, etc. Indicators tied to population growth did change, such as property tax base and greenhouse gas emissions.

Phase 2 – Vision – This is where we get to change variables to see how the modeling and forecasting changes. What happens if we change where we develop multifamily housing or how much tree canopy we have.

Much work remains to be done. Join us on May 8<sup>th</sup> at 6PM at Court Street Christian Church 1699 Court Street to hear the draft results of the first phase, and results of the first greenhouse gas emissions inventory.
