PAUL EVANS - SPIRE Grant

Was designed to provide necessary equipment to be used during massive scale disasters by people who would normally not be able to afford such a piece or pieces of equipment.

A story about the emergency response actions in Vernonia during the flooding.

5 million to be granted on a prioritized basis.

The intent was to purchase and stage some of that equipment around the state.

The original goal was to have 10 items, and only 10 items. Well, that changed a bit. There will be a phase 2.

Looking to put 20 million towards the next phase.

The long term goal is to purchase it, depreciate it over a schedule, then gift the residual value (asset).

Engage with your city and county emergency managers to talk about what equipment and where.

The other thing you can do is come and testify during the hearings.
