Ethics Commitee Findings 072020

On June 16, 2020, Irma O. Dowd, City of Salem Neighborhood Services Coordinator, spoke with WSNA Chairman Kevin Chambers in regards to information she had acquired regarding a potential violation of the Salem Revised Code (SRC). The WSNA Bylaws, ARTICLE X. ETHICS, Section 1 state:

Chairman Chambers and Members of the West Salem Neighborhood Association (WSNA),

Section 1. All officers and committee members shall abide by Salem Revised Code Chapter 12 as described at:

http://www.cityofsalem.net/code/salem-revised-code-012-ethics-for-public-officials.pdf. For purposes of this Section, the term Public Official, includes officers and committee members of the West Salem Neighborhood Association, and their agents, irrespective of whether the person is compensated for such services.

On June 17th, the City of Salem received a series of emails from a WSNA member voicing concerns about "...very unprofessional comments posted by West Salem Vice Chair, Mark Coutis, on the West Salem Neighborhood Association Facebook page". On June 18th, Chairman Chambers, in accordance with the WSNA Bylaws, ARTICLE X. Section 3, appointed an Ethics Committee "...to investigate the entirety of any and all the comments/interactions...." as potential violations by Mr. Coutis, and to report back to the WSNA Chairman and Membership its findings and recommendations.

The Ethics Committee reached out to the individual whom Chairman Chambers identified as the formal complainant in the matter; that individual acknowledged receipt of the Committee's request but has not provided a statement with the specific details of the ethics complaint against the WSNA Vice Chairman. Therefore, absent a detailed formal email complaint, our

committee's review of complaints focused primarily on the words and condemnations published on the West Salem Neighborhood Association Facebook page and Mr. Coutis' behavior at the June 15th monthly WSNA meeting.

The airing of real and deep concerns regarding the words and behavior of Mr. Coutis in his position as WSNA vice-chair were expressed in Facebook postings. There were also the personal accusations and truncated screenshot evidence posted on the WNSA Facebook page against Mr. Coutis by Jacob Townsend, a previous employee of Mr. Coutis. Mr. Townsend, from all evidence we have seen, is not an eligible member of the WSNA. However, he posted on the WSNA Facebook page an inflammatory statement that Mr. Coutis had made on a personal FB page in response to recent BLM protester activities that said "They need to get their asses tied to a tree and whipped!!" This particular statement flamed the fires of discontent that were already burning on the WSNA Facebook page as a result of the comments and Mr. Coutis's gestures at the WSNA monthly meeting. Mr. Coutis's comments and actions did not make others feel welcomed or comfortable in stating their perspectives. A community leader asking someone if they were "that clueless," when the individual spoke up voicing an opposing perspective to a statement Mr. Coutis had made, is offensive. No one should be personally attacked for voicing their opinion; especially when the attacker is an individual in a leadership position.

The individual members of the ethics committee did not come to unanimous consensus in our individual interpretations of the language in the Salem Revised Code Chapter 12. The Ethics Committee is guided by the following obligation: West Salem Neighborhood Association

officers are required to "observe in their official acts the highest standards of morality, and that their conduct in both their official and private affairs should be above reproach." (SRC, Chapter 12) The question that needs to be answered is whether Mr. Coutis's actions constituted an ethics violation as defined by SRC. If so, his actions would warrant taking action per Article X in the WSNA Bylaws. We on our committee are not lawyers and should not be acting as such.

Because the comments, complaints, examples of perceived harassment, threats received and perceived by multiple individuals as evidenced from the assemblage of WSNA Facebook postings following the June 15 virtual WSNA Zoom meeting, our committee has determined that this investigation and the interpretation of SRC Chapter 12 are beyond the scope of the Ethics Committee.

We recommend that our WSNA Chairman, Kevin Chambers, draft and submit a letter to the City of Salem requesting that staff, including their legal team, do a substantive and thorough investigation into the potential ethics violations, determine what action, if any, should take place in accordance with Salem revised code and the West Salem Neighborhood Association Bylaws and report back to the WSNA. We also recommend that the conflict resolution organization Neighbor-to-neighbor <a href="http://n2nmediation.org/">http://n2nmediation.org/</a> be contacted for additional training and conflict resolution for the WSNA body and executive committee.

The West Salem Neighborhood Association 2020 Ethics Committee moves that the WSNA Chairman Kevin Chambers draft and submit a letter to the City of Salem requesting the City, including the legal department, investigate potential ethics violations regarding the language and
