 City has plans to make this a connecting street to relieve some of the

congestion on Wallace, not the same as original plan Current City Councilor for this area has moved out of the area and resigned. Virginia Stapleton voted in but will not start until January (unless decided otherwise at City Council meeting - she is attending City Council meetings, just doesn't have a vote until her official term)

Possibly set up a meet and greet with new City Councilor, Virginia Stapleton.

b. WS Cert Members Update - Vanessa

Community Emergency Response Team (CERT)

Vanessa invited local CERT members to attend WSNA meetings, and asked about potential interest in volunteering to chair and participate in the Disaster Recovery Committee

State has emergency response team grants, may be able to access these when we identify needs, would be able to work with Paul Evans to apply and receive grant funds for WS

Mike is also asking local businesses to get involved.

c. Committee Reports new process- Mike

Goal is to better communicate to the community. Mike would like to see reports written ahead of time so that they can be posted to Facebook pages prior to general meetings. This would allow community members to read ahead of time and be more informed for asking questions.

Reports to be submitted 10 days before the general meeting to allow for posting with the agenda. Steve Anderson asked for Saturday morning rather than end of day Friday - Saturday prior

Micki has a parks meeting update the Thursday before the general meeting. Possibly summarize and post to Facebook before the Monday evening without a full written report on this one.

Vanessa to send out a reminder to submit reports (send reminder about one week before due).

i.Parks (Micki)

Camping in parks - sent letter that they cannot approve camping in parks due to the damage it does to parks.

Parks division and NAs have not been consulted for input

The City Council has extended an emergency declaration for a year. City has not provided an acceptable solution. Next City Council meeting on 11/23 - possibly exec board to show up for public comment to represent WSNA - discuss at next WSNA meeting.

Resolution from one Neighborhood Association did not state that the City should be relying on the network of Neighborhood Associations to get feedback on plans. There's an opportunity to be proactive and ask to be included in problem solving.

Gretchen Bennet from the city manager's office to join the next WSNA general meeting and provide an update.

Mike will stay in contact with City Councilor Jim Lewis to encourage action on this subject.

ii.Welcoming and Inclusion (Steve)

Working on posters to post around West Salem. Currently working on design, to include what the WSNA is, why people should attend, and when meetings are, how to join. Draft will be available to the Exec Board and possibly general members before printing. This would be one time printing - design will be general enough that they can stay up for a while (e.g., meetings on 3rd Mondays).

Irma can print in house, but didn't state how much it would cost. Would like to request \$100 to print about 100 posters.

Important to find routes to get messages about WSNA out to get information to the community so more people know about WSNA.

EM moves up to \$150 for printing posters (to allow wiggle room in case cost is more than \$100), Jason seconds, all in favor

Jason brings up possibly purchasing a domain until we have a website built. It could point to the City's WSNA page until our website is ready. This expense would be approximately \$30/year. WestSalemNA.com is available (.org is not). Jason would also grab Instagram and Facebook handles.

EM moves to approve \$200 expense for domain, Steve A seconds, all in favor

iii. Transportation (Nick)

Nothing to report right now. Transit meeting that Nick couldn't attend, but will follow up.

Steve A suggests Nick to make a report on occasion to keep everyone informed.

iv.Land Use - Steven

Mike contacted Drew Cornedi, architect working on Myers Elementary. They also need input on parking lots near West Salem High School. Could he do both updates at the next general meeting?

Steve A suggests exec board go view the site (Myers) to determine our recommendation.

Micki would like to know why they need to take out the trees - due to

needing to widen the sidewalk per code.

Vanessa asks if the school community has been consulted for their recommendation and preference. WSNA could ask through their contact list for input on the issue.

If recommendation is to remove trees, can we ask for additional trees to be planted on school grounds in replacement.

Northwest Edgewater - 2nd Street Edgewater District - asked for variance on the set back

Is 2nd Street more pedestrian friendly?

Short brick wall between parking and sidewalk, stormwater garden, green spaces, 8 foot wide sidewalk, added benches

Steve A recommends that we support the project, and that they met the intent of the requirements even though they changed from the original plan. Request that they include native plants where possible. EM moves, Jason seconds, all in favor.

Email Jason with any ideas about our website. Jason shared examples of other neighborhood association websites.

Preference for visual communication - not a lot of blocks of text on the home page.

Jason to continue looking into what it will cost to build a website.

ix.Budget/fiscal

We do not automatically get a budget. We can earn \$500 per year. This is a change from past practice - used to get an automatic amount and then volunteer hours to earn more.

Mike contacted Irma about earning our credits for volunteer work and outreach communications (Westside News).

We currently have about \$1500 in our account currently.

- x.Courtney Knox Bush invited Mike and Jason to a meeting with the City on 11/18/20 regarding city policing and the climate action plan.
 Climate action plan includes trees but does not include natural areas.
 Steve A recommends that we advocate for natural areas to be included in the plan.
- xi.Mike reached out to the police department to see when we could get someone to come to our general meeting to provide an update. We should request a monthly update of crime statistics at each meeting.
- xii.Kudos to Steve VP and Welcome and Inclusion Committee for the recent article in Westside News. Due date for the next issue is coming up the new Board should put out a welcome letter.
