Dear Salem Property Owner/Resident:

Pacific Excavation, Inc. has been awarded the contract to construct pedestrian and bicycle improvements at five locations in Salem. One of the locations is Pine Street NE at Maple Avenue NE (see enclosed map). The improvements will include striped crosswalks across Pine Street NE with new ADA compliant curb ramps, bicycle safety enhancements, and a center island on Pine Street NE. To enhance pedestrian and bicycle safety, motorists will no longer be able to cross Pine Street NE at Maple Avenue NE or make left turns from Pine Street NE to Maple Avenue NE or from Maple Avenue NE onto Pine Street NE. This project is funded with an ODOT grant and City matching funds.

Construction activities are scheduled to begin the week of June 6, 2020, with completion by the end of July 2020. Motorists and pedestrians should use caution, as this work will require temporary lane shifting and sidewalk closures. This work may create traffic congestion within the area and users should expect delays.
