ADMINISTRATIVE RULE SUMMARY

The purpose of the proposed rule is to modify Administrative Rule 109-001 to reflect recent updates to SRC Chapter 74 (Pretreatment Provisions). Staff will present to Salem City Council on **April 12, 2021**, amendments to the definition of Best Management Practices: Pretreatment and Monitoring Systems contained in Administrative Rule 109-001_109-007-public-works-design-standards_0001.

BMP—Best Management Practices (BMPs). As it applies to storm water systems: The technique, measure, or structural control that is used for a given set of conditions to manage and prevent erosion, control sediment, and improve the quality of storm water runoff.

Best Management Practices (BMPs). As it applies to Pretreatment and Monitoring Systems: ~~means~~—The schedules of activities, prohibitions of practices, maintenance procedures, and other management practices as described in 109-001_109-007-public-works-design-standards, DIVISION 003 SANITARY SEWER COLLECTION SYSTEM, 3.4—Pretreatment and Monitoring Systems. to implement the prohibitions listed in section 40 CFR 403.5(a)(1) and (b). BMPs also include treatment requirements, operating procedures, and practices to control plant site runoff, spillage or leaks, sludge or waste disposal, or drainage from raw materials storage.

The proposed administrative action to be taken is to modify Administrative Rule 109-001 General-Design Standards. Administrative Rule 109-001 is being modified to reflect recent updates to *Salem Revised Code* Chapter 74 (Pretreatment Provisions).
