Dear Salem Property Owner/Resident:

The City of Salem has finalized the design to convert State Street from one-way to two-way traffic from Liberty Street to Church Street. This project was developed and adopted by the City Council as part of the 2013 Central Salem Mobility Study. The project limits are shown on the attached map. Construction is scheduled for summer 2020.

Construction activities will affect the normal flow of traffic in the area of the project site, both during and after construction. While all roadways will be open to through traffic during construction, one lane and parking may be impacted at times on State Street near the intersections of State and Liberty Streets and State and High Streets. Every effort will be made to complete the project as quickly and safely as possible. Your patience is appreciated during construction.

As the construction start date approaches, you will receive additional correspondence regarding the construction schedule.
