1200Z PERMIT COMPLIANCE

What is the 1200Z Permit?

It is a National Pollutant Discharge
Elimination System (NPDES) Stormwater
Discharge Permit issued by the
Department of Environmental Quality
(DEQ) to industrial facilities that may
discharge industrial stormwater to surface
waters. This permit has specific procedures
to prevent pollutants from industrial
activities from leaving the site. A copy of

How to Use this Permit

The permit holder for the Salem Municipal Airport 1200Z permit is the City of Salem. While the City of Salem is responsible for



sampling and reporting for the permit, each tenant is responsible for being aware of the permit requirements, maintaining a clean site, and preventing any pollutants from making contact with stormwater or reaching the creek.

Employee Training

- Follow all employee education and training requirements on pages 11 and 12 of the permit, including annual training of all employees, and training of any new employees within 30 days of hire. Contact City of Salem for assistance with training needs and documentation.
- Upon new hire, have employee(s) visit the <u>1200Z Permit training website</u>, read the 1200Z Fact Sheets, and complete the training quiz.
- Report all new hires, as well as annual training records, to the City of Salem at 1200Z@cityofsalem.net.



How to Stay in Compliance

- Create and follow a Spill Prevention and Response plan for your site in accordance with guidelines in the permit.
- Inspect your spill kit monthly to make sure it has all necessary materials, that all materials are still in good condition, and that the kit is easily accessible.
- Report any spills or concerns to the City's 24-hour Dispatch at 503-588-6311.
- Inform the City of any significant or hazardous materials you are using, such as fuels, cleaners, etc.
- Follow all Narrative Technology-Based Effluent Limitations (TBELs). For more information, see the TBEL Fact Sheet.
- Practice good housekeeping, implement best management practices (BMPs), and follow information provided on NPDES 1200Z Fact Sheets and other educational materials provided by the City.
- If you make changes to your site that will affect stormwater, or if you update your spill response plan, please inform the City by calling 503-588-6311 or emailing 1200Z@ cityofsalem.net.
- Failure to stay in compliance will be met with action from the City of Salem, including, but not limited to, receiving a noncompliance letter and an in-person meeting between City staff and tenant. The City is here to assist you, so please contact us if you have any questions.
