Historic Design Review Case No. HIS16-36MOD1 for 148 Liberty St NE Major Historic Design Review of a proposal to modify a previous historic design review approval (HIS16-36) to modify the front facade of Engleberg's Antiks(1915), a historic noncontributing building in Salem's Downtown Historic District, zoned CB (Central Business) zone, and located at 148 Liberty Street NE, 97301 (Marion County Assessor's Map and Tax Lot number: 073W27AB05400).
