Each permit application must be accompanied by:

- **Permit fee** \$39 per calendar day, if applicable. There are fees for multiple-day events.
- Certificate of Insurance food and drink vendors must submit insurance naming the additional insured as the "City of Salem, its officers, agents, employees, and volunteers."
