

**NOTICE OF PUBLIC COMMENT PERIOD AND PUBLIC HEARING ON  
City of Salem  
2022 Annual Action Plan (AAP)  
For Publication on February 21, 2022**

The City of Salem annually receive HOME Investment Partnerships and Community Development Block Grant (CDBG) program funds from the Department of Housing and Urban Development. Annual Action Plans (AAP) are a component of the five-year Consolidated Plan that specifically describe how the City of Salem will spend the federal resources for activities serving low-and moderate-income persons, the homeless, and persons with special needs.

The draft AAP is available for public review and comment from Monday, February 21, 2022 through Wednesday, March 23, 2022. All comments must be received no later than 5 p.m. March 23, 2022. Copies are available for review during regular business hours at the City of Salem Public Library, 585 Liberty St. SE, Salem, OR.

The draft documents can also be obtained from the City of Salem Urban Renewal Agency located at 350 Commercial Street NE, Salem, OR 97301. Copies will be provided at a reasonable cost. The Salem City Council will hold a public hearing at 6 p.m., Monday, April 25, 2022.
