Infrastructure Bond Engagement Steering Committee,

I am unable to (virtually) attend today's meeting, so I wanted to take this opportunity to write in support of infrastructure bond funds directed toward protected bike lanes and other actions as proposed in the Salem Bike Vision. The Salem Bike Vision is a forward-thinking proposal that will prepare Salem for a truly multi-modal transportation network, and safer and healthier communities, amid a rapidly changing climate.

I live in north-central Salem, and commute 5 miles by bike to my workplace in south Salem. Every morning, I don my super-reflective clothing, activate my three high-intensity strobe lights, and set forth into traffic. I am an experienced cyclist, including 5 years of competitive racing, 4 years commuting by bike in Washington DC, and multiple long-distance bike journeys across various countries. yet some of my most terrifying and terrible experiences are here in Salem. It is not safe to take the existing bike lanes when there are vehicles going 50+ mph to the immediate left, and roadside debris (glass, tree limbs, gutters) to the immediate right. It is then positively murderous when those bikes lanes are intersected by commercial parking entrances every 50 feet. And those are the roads with _designated_ bike lanes...
Meanwhile my wife will not ride her bike with me to the Saturday market. I live one mile from the Saturday market.

This was probably not the most useful of public comments -- I can only hope you are well-aware of these issues. So I would ask you to please substantively support the Salem Bike Vision into this infrastructure bond planning. It is completely practical yet has the potential to dramatically transform our Salem lives and livelihoods.

Public Opinion & Community Research—Recap Infrastructure Bond Engagement Steering Committee April 15, 2022

Community Focus Groups (September 2021)

- Homelessness and crime are top issues.
- Support increases after learning this would not increase property tax rates.
- Support increases when more information is provided.
- Voters want to know if projects align with their priorities.

Telephone Survey Highlights (January 2022)

Support for the bond measure increases from 49% (very likely, somewhat likely) to 60% when voters learn they could approve bonds without increasing property tax rates

SUBJECT:

Since the Committee began its work in December, 2021 there has been great progress made toward putting together a comprehensive Infrastructure Bond recommendation to City Council for the November, 2022 ballot. The Infrastructure Bond has been built on the following pillars:

- \$300 Million package
- A levy rate of \$1.20 / \$ 1,000 of assessed value on tax bills
- A 10 year duration which will have several issuances of the \$300 Million package

Thus far, the Committee has recommended the following to be a part of the package that will be forwarded to City Council for consideration:

- Civic Center Earthquake Safety Improvements: \$39,400,000
- Technology and Cybersecurity: \$17,620,00
- Sites of Affordable Housing / Branch Library Locations: \$7,500,000
- Affordable Housing Opportunity Funds: \$10,000,000
- Fire Engines and Equipment: \$26,000,000

The above projects total \$100,520,000, leaving approximately two thirds of the bond package available to allocate.

The goal of the meeting this afternoon will be to decide on the below projects, including their amounts. Currently, staff is proposing the following allocation.

• Future Fire Stations: \$14,000,000

• Streets and Sidewalks: \$157,075,000

• Park Upgrades: \$31,184,000

The recommended reductions include:

- Marine Drive reduce to phase 1 of Harritt to Taybin reduction of: \$24,000,000
- Pringle Creek Path fund half of project URA funds when available reduction of: \$3,575,000
- River Road S Slide Mitigation remove project reduction of: \$20,000,000
- Fisher Road Park Development remove project, fund with SDCs reduction of: \$2,840,000

- Orchard Heights Park Parking Lot Renovations remove project reduction of: \$280,000
- Wallace Marine Park Sports Field Lots Pavement remove project reduction of: \$1,260,000
- Cascades Gateway Park Walter Wirth Parking Lot Pavement remove project reduction of: \$1,480,000
- Pavement R&R Edgewater Street NW: Wallace Rd NW to 200 feet East of Rosemount Ave NW remove project reduction of: \$1,040,000
- Signal Replacement Portland Road NE at Lana Avenue NE remove project reduction of \$2,030,000
- Orchard Heights Dog Park remove project reduction of \$550,000

Staff is available to walk through any questions you may have during the meeting on April 15, 2022 with the Committee. Most of the reductions were based on feedback during the last Infrastructure Bond meeting on April 4, 2022.
