Class 3 Site Plan Review for a proposed 1,700 square foot building addition to an existing building for a total proposed floor area of approximately 18,858 square feet, with the following Class 2 Adjustments to:

- 1) Eliminate the required pedestrian connection between the building entrance and 22nd Street SE; and
- 2) Eliminate the required pedestrian connection between buildings on the same development site.

Failure to raise an issue in writing prior to the close of the Public Comment Period with sufficient specificity to provide the opportunity to respond to the issue, precludes appeal to the Land Use Board of Appeals (LUBA) on this issue. A similar failure to raise constitutional issues relating to proposed conditions of approval precludes an action for damages in circuit court.









VICINITY MAP



















### **EXISTING** WEST ELEVATION SPR-8 SCALE : 1/8" = 1'-0"
