PROPOSAL REQUEST:

A Class 3 Site Plan Review application to change the use of the Carpentry Shop building of the former Fairview Training Center to Office together with associated interior improvements to establish nine proposed office spaces within the building and exterior site improvements including off-street parking, bike parking, and woonerf street improvements along Cousteau Drive SE and Village Center Drive SE. The subject property is approximately 0.29 acres in size, zoned FMU (Fairview Mixed-Use) within Area 3 of the Pringle Creek Community refinement plan, and located at 3996 Cousteau Drive SE (Marion County Assessor Map and Tax Lot Number: 083W02DC01600).

APPLICATION PROCESS:

Following the close of the Public Comment Period, a decision will be issued and mailed to the applicant, property owner, affected neighborhood association, anyone who submitted written comments, and anyone who received notice of the land use request.

Failure to raise an issue in writing prior to the close of the Public Comment Period with sufficient specificity to provide the opportunity to respond to the issue, precludes appeal to the Land Use Board of Appeals (LUBA) on this issue. A similar failure to raise constitutional issues relating to proposed conditions of approval precludes an action for damages in circuit court.





Vicinity Map 3996 Cousteau Drive SE







