Annual Action Plans (AAP's), required for the City of Salem to receive and spend funds from the U.S. Department of Housing and Urban Development (HUD), are available for a 30-day public comment period beginning December 19, 2022. The Plans provide information on recommended projects for Salem's use of HOME and Community Development Block Grant (CDGB) funds.

The 2019 AAP Amendment #6 proposes reallocating approximately \$277,000 of CDBG-Cares Act funds to Marion and Polk Food Share, for purchase of food and staff costs for distribution to vulnerable persons during the reoccurrence of Covid illness.

The 2021 AAP Amendment #2-proposes reallocating \$450,000 of HOME funds to Sequoia Crossings Limited Partnership for the Sequoia Crossings Apartments project for new construction of 60 affordable rental housing units.

The 2022 AAP Amendment #1 proposes reallocating \$650,000, \$50,000 from 2021 and \$600,000 from 2022 of HOME funds to Gateway Phase I Limited Partnership for the Gateway-Salem Apartments project for new construction of 184 affordable rental housing units.

The listed plans are available for public review and comment from December 19 – January 20, 2023. All comments must be received no later than 5 p.m., January 20, 2023.
