resolution no. 7986

WHEREAS, there exists within the City of Sales, Oregon, blighted areas or deteriorated areas as defined in Chapter 457, Oregon Revised Statutes; and

MHEREAS, Section 457.130, Oregon Revised Etatutes, created in the City of Salem a public body, corporate and politic, for the purpose of exercising the powers granted by said chapter, but provided, pursuant to said one 457:130 that said public body, corporate and politic, shall not transact any business or exercise any powers, unless by resolution, the Common Council of the City of Salem, Oregon, declares there is a need for such agency to function; and

WHEREAS, said ORS 457.130 provides that the provisions for urban renewal provided by said chapter of said Oregon Revised Statutes shall not become operative in any municipality until the legislative body of the community declars by resolution that there is need for urban renewal in the community; now, therefore,

BE IT RESOLVED BY THE COMMON COUNCIL.

OF THE CITY OF SALEM, OREGON:

section 1. It is hereby found and declared, pursuant to ORS 457.130, that there is a need for the agency created by said section of the Oregon Laws to function in the City of salem, Oregon, and said agency is hereby authorized to transact business and exercise its powers under the urban renewal development statute.

Section 2. It is hereby found and declared, pursuant to ORS 457.130, that there is need for urban renewal, as defined in said chapter of said statute, in the City of Salem, Oregon, and that all of the provisions of said chapter of Oregon Revised Statutes are operative in the community and applicable to the agency provided in Section 1 hereof.

Section 3. Pursuant to the provisions of ORS 457.170, the Common Council hereby declares itself to be the agency provided in Section 1 hereof, that sit of the rights, powers, duties, privileges and immunities vested by the Dees of Oregon in such agency, shall be, and are, vested in this body.

<u>Section 4.</u> The corporate name of the agency provided by this resolution shall be, and the said agency shall be known as "The Urban Renewal Agency of the City of Saiss," Oregon".

WHEREAS, all funding for urban renewal projects from the federal government is directed to the City of Salem; and

WHEREAS, under the provisions of subsection 3 of ORS 457.210 the urban renewal agency adopted Resolution No. 758 delegating its powers or functions to the City of Salem with respect to the planning or undertaking of an urtan renewal project; and

WHEREAS, under the conditions as aforesaid it would be in the public interest and the general welfare of the community that such powers and functions of the agency be so accepted by the city: NOW, THEREFORE

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF SALEM, ORECON:

THAT all powers or functions of the Urban Renewal Agency are hereby accepted by the City of Salem, Oregon and the said city shall carry out or perform such powers or functions to the fullest extent allowed under the laws of the State of Oregon.

RESOLUTION NO. 758

RESOLUTION DELEGATING AGENCY'S POWERS OR FUNCTIONS TO THE CITY OF SALEM, OREGON

WHEREAS, by Resolution No. 7986 adopted by the Common Council of the City of Salem, Oregon, October 23, 1961, the Urban Renewal Agency of the City of Salem, Oregon, was created; and

WHEREAS, pursuant to the provisions of the ORS 457.145 the Common Council did by said resolution declare that it would exercise the powers of an urban renewal agency; and

WHEREAS, by Resolution No. 745 adopted by the agency June 16, 1975, all agency employees have been transferred to the City of Salem and the duties and functions thereof are now being performed by the Department of Community Development of the City of Salem; and

WHEREAS, all funding for urban renewal projects from the federal government is directed to the City of Salem; and

WHEREAS, under the provisions of subsection 3 of ORS 457.210 an urban renewal agency is authorized to delegate any of its powers or functions to the municipality with respect to the planning or undertaking of an urban renewal project; and

WHEREAS, under the conditions as aforesaid it would be in the public interest and the general welfare of the community that such powers and functions of the agency be so delegated to the city;

NOW, THEREFORE, BE IT RESOLVED BY THE URBAN RENEWAL AGENCY OF THE CITY OF SALEM, OREGON:

THAT pursuant to ORS 457.210 (3) all powers or functions of the agency are hereby delegated and transferred to the City of Salem, Oregon and the said City is authorized to carry out or perform such powers or functions to the fullest extent allowed under the laws of the State of Oregon.
