1. **Call to Order** – With a quorum present, Chair Hull called the meeting to order around 2:30 p.m.
 2. **Public Comment**
Chris D’Arcy, Ward 2, submitted public comment via email before the meeting. Keith forwarded the comments to the Commissioners prior to the meeting. Keith read the contents of the email to SPAC. The email is attached to these minutes.
 3. **Approval of Consent Agenda**
 - a. Approval of the February 8, 2023, Agenda; Meeting Minutes of January 11, 2022.

Motion: Vice-Chair Napack motioned to approve the consent agenda and minutes. Commissioner Sellers-Young seconded the motion. The motion passed unanimously.

4. **Discussion Items**
 - a. **Staff Report by Allen Dannen:** Allen Dannen showed SPAC renderings of the Public Works Operations Building currently being constructed at the City Shops Complex. This project allocated about \$140,000 to public art as part of the percent for art program, which is required for capital infrastructure projects, like buildings. Similar to the Police

Station and Library upgrade project, the public art aspect of this project started with a request for qualifications from interested artists. In early 2022, the project management team worked with SPAC members to solicit a pool of interested artists, review artistic concepts, and select winners. The art selection committee requested two concepts for the building – an exterior piece in the entrance courtyard and a second opportunity in the interior in the customer service lobby area. Allen Dannen showed the group progress photos of Brad Rude’s ram and beaver sculpture for the entryway and Claire Burbridge’s wallpaper and drawing for the customer service lobby area. September to early October 2023 is the anticipated move-in date, and the artwork will be installed just before the move-in date. Chair Hull inquired about having an unveiling ceremony for the artworks. Allen would like to coordinate with SPAC an event similar to the police station artwork unveiling. Allen said that there will be a ribbon cutting ceremony for the building itself, and that the artwork unveiling will have a separate celebration either on the same day or at another time.

Allen talked about the passage of the Community Infrastructure Bond and the resulting funds that will be allocated to public art as a result of the percent for art program outlined in City Code. Public Art will be part of the replacement of Fire Station #8, which site selection is planned for 2023-24. Allen will engage SPAC in late 2023 or early 2024 to set up a similar committee to select public artwork for the project. The anticipated Civic Center improvements will yield a large public art allocation and construction is scheduled in 2026-28. Allen will engage SPAC in 2025 to begin discussions about selecting the public art to go along with these projects.

There are a number of parks projects totaling roughly \$28 million, and some of these projects are for new or replacement restroom facilities. Allen suggested SPAC think about pooling the contributions from each one of the four or five restroom projects into one large project. The first project is anticipated to start in 2024-25 and is located at McKay High School Park. Allen said that it is a bit early to start talking about these projects and if Engineering waits until final costs are solidified, there may be more money to spend as costs increase over time. Construction costs for parks restroom facilities is estimated at \$4 million, which equates to a total of \$20,000 for a public art allocation.

b. SPAC Visioning Discussion:

Keith reported the following in response to the questions posed at the December 14, SPAC meeting.

Commissioner Napack mentioned the current installation at Bush House Museum that projects light art images in a space and thought an outdoor installation would be a cool performative art projection piece that could be considered as public art. The commission discussed the possibility of having temporary artwork in the City. **Keith will need to check with the City’s Legal department to see if temporary installations of community/city artwork is supported by City Code.**

Commissioner Napack wanted to know if someone from an arts organization in Salem receives money from the City, would it be a conflict of interest if they served on SPAC? **Keith has asked Legal that question and is awaiting a response.**

Commissioner Sellers-Young wanted to know if there is a list of arts organizations in Salem and if SPAC can have conversations with them. Commissioner Sellers-Young complied and emailed Keith a list she developed of local arts organizations and included Neighborhood Association Chairs and Land Use Committee Chairs. Irma Coleman, the City's Neighborhood Associations Coordinator, sent Keith the updated list of neighborhood Association Chairs. **Keith will distribute Commissioner Sellers-Young's list and Irma's list to SPAC via email.**

Chair Hull would like SPAC to provide content to staff for social media posts; possibly ask commissioners to send content to Keith to post on City's social media accounts. Can SPAC have their own social media channel? **Keith reported that SPAC cannot have their own social media channel, because the City has existing media platforms and a procedure for its Boards and Commissions to follow. SPAC just needs to send drafted messages and images for posting onto the City's social media pages at least two days prior to the desired posting date.**

How can SPAC interact with the existing Neighborhood Associations structure? Commissioner Napack suggested reaching out to Irma Colman in Neighborhood Services to perhaps put together a SPAC powerpoint and ask Irma to see if there are NA's interested in having SPAC do a presentation and get the word out on the community art survey. **Keith spoke with Irma Coleman, Neighborhood Services Coordinator, who will be meeting with the NA chairs on January 22. She will notify them of the Transportation Occupancy Tax (TOT) funding available for the street painting program. Irma will provide Keith with a current list of NA emails and SPAC can reach out to the Chairs to schedule time on their agenda (and cc: Irma).**

Who needs to approve of the survey questions and how does it get distributed within the community? What is the tool and how does it work?

Keith spoke with Trevor Smith, City's Public Information Officer, and he said that SPAC and other boards and commissions cannot have their own channel, and the city controls their platforms. There is a city process for groups to put in for their social media postings. The Stormwater education and outreach program sends an email at the beginning of each month to Trevor and the Communications Team that contains weekly social media posts for that entire month, 3 or 4 stories. Keith suggested that the commissioners consider that route to help SPAC meet their social media desires. Commissioner Hull wanted to know if anyone would like to be responsible for organizing that and to serve as a point person to produce a monthly social media post? Commissioner Napack does it for her volunteer organizations and would be willing to do it for SPAC. She thinks it is something easy and could focus on public artwork that the city already owns. She suggests doing one posting of a public art piece weekly for the entire year, adding additional posts for special events or other topics requiring their own posts. Keith showed SPAC the collection management spreadsheet of the 172 pieces the city owns. Chair Hull and Vice-Chair Napack would like to start an "art column." Chair Hull wants to "put some of these in the can," to be ready for weekly publication. Keith will work with IT to provide Commissioners access to the City's art collection files, so they can help with developing weekly social media posts.

- c. **Community Survey of Public Art:** Keith has not received any additional questions from the Commissioners for consideration into a community survey. Commissioner Hull would like staff to finalize the next steps for the survey, so he asked Keith for some deadlines. Keith said he will email the group with a deadline to provide questions so that he can draft a survey for the Communications Team to review.
- d. **Collection Management System for City's Art Collection:** Keith showed the Commissioners the City's spreadsheet database of the public art collection and file system. In order for the Commissioners to provide content for social media posts, access to these files would be invaluable, so Keith will work with IT to gain access for the Commissioners, potentially some kind of FTP site.
- e. **In-person Meeting:** The Commission desires to meet in person at the April 12 meeting. Keith will put in a request with the Public Works Director as outlined in City policy and procedures.

5. Updates

- a. **SPAC Vacancy:** Keith reminded the group that there is one vacancy for a member experienced in museum curation, art restoration, or art appraisal.
- b. **City Councilor Linda Nishioka's Motion:** Chair Hull would like to champion the code changes effort and would like to work with Vice-Chair Napack on the idea of the other types of objects that could be painted, which could be part of the suggested code review in Council. Keith reported that the City's Legal department is currently reviewing a proposed language change to the code so that the storage tanks at Pacific Coast Producers' mural can be painted, along with other non-planar surfaces.
- c. **SPAC 2022 Annual Report into a PowerPoint:** Keith will work to compile a PowerPoint presentation for the annual report to council and for sharing with the neighborhood associations at their monthly meetings.

6. Maintenance Updates

- a. **Equitas Sculpture at Police Station:** Keith notified staff that SPAC had authorized funds for the repair of the vandalized piece.
- b. **Waldo Stewards:** Keith notified staff that SPAC had recommended that the graffiti be painted over and that an anti-graffiti coating be applied.
- c. **Drummer & Rooster:** Chair Hull had a conversation with Lee Imonen, who the Commission selected to repair the piece. Lee recommended not placing the piece back into the water for fear of continued degradation. He recommends repair and siting it somewhere dry. Allen Dannen said that he would contact the Commission for their involvement in the percent-for-art projects located at the Civic Center and Peace Plaza related to bond improvement when the time comes.

- d. **Good Cents:** Keith will put effort into securing resources for this cleaning.

7. **New Business**

- a. **City of Eugene's Approved Muralist List:** City of Eugene has a pre-approved roster model where muralists submit samples of their work, and they get approved by the City to do work in the City. Once the muralist is on the pre-approved roster, people who want to fund a mural on their buildings can simply select a muralist without further City approval. Chair Hull wants to look into this further because it is a different model, which could work. Commissioner Sellers-Young agreed that it is a good idea. Vice-chair Napack said a roster would not necessarily control content, which may have been the reason behind the Front Street mural proposal being pulled.

Good afternoon Keith,

I am providing some public comment for this afternoon's meeting of the Salem Public Art Commission.

I applaud Councilor Nishioka's efforts to update the City's mural code to include spaces other than flat walls. Tri-met has recently undertaken a program to commission artists to create designs to wrap buses in their fleet. The program solicits artists' qualifications for designs to mark commemorative months or other celebrations. This is the current call to celebrate Asian Pacific Islander Heritage Month. This concept could be considered for Salem and the Cherriot Transit buses.

My SCAN neighborhood is planning a street mural that will likely be painted in late spring/early summer. There has been some discussion of the need for traffic calming, especially near South Salem High School. I am not sure that a single intersectional artwork can remediate speeding in Salem, but there are some great examples of street and construction fence painting that could also be undertaken in Salem.
