1. Call to Order

The meeting was called to order by Chair Jake Krishnan. Attendance taken, quorum declared present. Approved minutes for December meeting.

2. City Councilor Report

Vanessa Nordyke gave report.

- New City Councilors sworn including Deanna Gwen for Ward 4
- Airport Improvement Budget approved by Council
- Budget Committee meets to review five year forecast
- PIT Count and other homelessness-related updates
- Statewide housing shortage

Council had a retreat at the Center for 50+

She went from job at the DOJ to CASA. She gave rundown on CASA services helping to prevent domestic violence.

Council voted to fund \$2.4M for updating the Salem Airport. They will shortly begin to offer commercial air service. Funding includes support for TSA, police and firefighters. Commercial service will include LA, Phoenix, San Francisco and perhaps Reno and Las Vegas.

Gave info (roughly 500 people) died from the homeless population in Oregon. New Governor Kotak has declared a State of Emergency on homelessness, so there will be some resources coming from the state to address this issue

3. Officer Report

Police Officer Mark Burke gave report.

Homeless service team is working to assist people in camps to keep them clean. They have contacted over 500 camps in the past two months and are referring people to available services.

Question on Neighborhood Watch service. Wanted to know how residents can get involved. Officer Burke said that they can call non-emergency police number to inspect any nefarious situations.

Question on unmanaged camp in triangle where Commercial Street and I-5 intersect. Officer Burke said he will mention it to the Homeless Service Team. Is located on private property so they cannot relocate the camp. It is the responsibility of the property owner.

Question on master key opening the Terrace Lake mailboxes from the mail service side. They were pilfered and left open.

4. Election of Board Members

Jake Krishnan is retiring from the Board.

Loyne Gwyn dropped his nomination for the Board, but will remain active with SGNA.

Board members up for election gave introductory summaries of their experience and answered any questions from the neighborhood.

Glenn, Bailey, Dave McKenna, Dynee Medlock and Jackie Leung were up for election and all were voted on to the Board.
