SUBJECT: SIGN CODE UPDATE

The public notice included with this mailing concerns an upcoming public hearing before the Salem Planning Commission regarding proposed amendments to the Salem Revised Code (SRC) Chapter 900, the Sign Code.

Examples of proposed changes include:

- Updating definitions contained within the Sign Code, including a definition of complex that will replace shopping center, industrial complex, and office complex. New definition added for primary wall.
- Removing Sign Adjustments and Sign Variances, and instead allowing development standards of the Sign Code to be adjusted or varied following the procedures of SRC Chapters 245 (Variances) and 250 (Adjustments).
- Adding additional development standards for electronic display signs in place of the Sign Conditional Use Permit.
- New prohibition on outdoor advertising signs within the MU-III (Mixed Use-III) zone.
- Updates to temporary sign standards, including definitions, display time limits, and allowance for sidewalk signs to be placed in some areas outside of the Downtown area.
- Establish a measurable brightness standard for illuminated signs.
- Establish a minimum setback distance between illuminated signs and residential zones.
- Reorganize and consolidate existing zone categories and clarify sign allowance for residential uses, non-residential standalone uses, complexes, and individual uses within a complex.
- Updating sign allowance for properties in the PH (Public and Private Health Services) zone, including facilities with emergency services.
- Clarification on nonconforming, unsafe, abandoned, and prohibited signs.

Other proposed changes clarify, correct, or simplifies standards and deletes old references to zones that have previously been eliminated.

Any person wishing to speak either for or against the proposed request may do so in person or by representative at the Public Hearing. Prior to the Public Hearing, written comments should be directed to the case manager listed below. Staff recommends emailing to ensure receipt before the public hearing. Only those participating by submitting written testimony, or by testifying at the hearing, have the right to appeal the decision. <u>Comments submitted are public record. This includes any personal information provided in your comment such as name, email, physical address and phone number.</u>

APPROVAL CRITERIA:

Salem Revised Code (SRC) Chapter 110.085(b) – Amendments to the UDC.

Subsequent to the close of the hearing, the Planning Commission will forward a recommendation to the City Council. Notice of the recommendation will be mailed to all neighborhood associations, anyone who participated in the hearing, and anyone who requested to receive notice. The City Council will make the final decision on the proposal.

The case file is available for review and printed copies may be obtained at a reasonable cost. A copy of the staff report will be available for inspection one week prior to the hearing.
