<u>Airport Manager's Report – July 19, 2023</u>

CURRENT PROJECTS:

FAA MALSR Replacement Project:

Project is complete.

Airport Beacon:

Replacing the decades-old beacon light has been determined to be the best
option in the short-term. A new beacon location would require additional cost
and studies to ensure no impact to air traffic control and the surrounding
community. Staff is researching replacement options and hope to have it
completed in time for commercial air service and winter weather.

Airport Master Plan Update:

- The first Planning Advisory Committee (PAC) meeting was held on May 23rd. The
 purpose of the meeting was to discuss draft Chapters 1 (Existing Conditions) & 2
 (Environmental Considerations), but also a broader discission about the
 airport's future infrastructure needs. Attendees were provided an opportunity
 to comment and ask questions. The next PAC meeting will likely be sometime in
 the Fall.
- Chapter 3 (Aviation Forecasts) is still being developed with input from FAA on likely levels of air carrier operations and enplanements. Avelo Airline's growth at similarly sized airports is being considered for forecasting purposes, but also a more aggressive forecast assuming locally based air carrier operations within the planning period.
- Two cost estimates are under development for future City Council consideration; one for costs associated with keeping RWY 16/34 open during the planning period, and the second for costs associated with closing the runway and building new infrastructure to service the primary runway from existing facilities. The city will likely seek an independent review from another airport planning/engineering firm of the estimates before making a presentation to City Council.

COMMERCIAL AIR SERVICE:

Airline Announcement:

On Thursday, July 13th Avelo Airlines formally announced non-stop service twice per week to both Las Vegas and Burbank, beginning on October 5th and 6th respectively. LAS service will be Thursday/Sunday flights and BUR will be Friday/Monday flights. Tickets are available now on their website at https://www.aveloair.com/ As we know, the community's support of this air service will ensure its long-term viability and growth.

Terminal Improvements:

 Project is nearly complete, other than some punch list items which should be done by the end of July. TSA's delivery, installation and testing of their equipment is scheduled for September 12th-13th.

Staffing:

- The Airport Security Manager position has been filled and Aaron Ison, is joining us from Boeing Field. His first day is Monday July 17th.
- The Credentialing Program Coordinator, Micah Aldridge began with the airport on June 5th. Micah joined us from PDX.
- The Administrative Analyst position has been filled. Kendrick Arakaki joined the airport staff on July 3rd and came to us from Willamette University.
- Two additional Maintenance/Ops/Security staff, Patrick Tope and Matthew Brooks, are joining the airport on Monday, July 17th. The fourth of four positions has signed his offer letter and is awaiting his release from the military at Joint Base Lewis McChord later this summer.

Airport Security Plan/Program:

- The complete draft plan is in final TSA review, with approval anticipated by end of summer.
- TSA approved two key chapters in advance of the rest of the plan to allow for provisioning of criminal history background checks, security threat assessments, and issuing badges, which we expect will be ready by end of July or early August.
- Public outreach to airport users, businesses, and others on how the security changes will affect them as they enter, exit, and move about the airport are

forthcoming. Airport users that DO NOT require access to the Secured Area (the commercial parking ramp and restricted areas within the terminal) will be issued an AOA badge that will be required to be displayed while on the airport. The AOA badge will differ in color (green) from the badges required to be worn in the Secured Areas (red).

A security improvement capital project is being developed using existing FAA grant funds to improve security at the airport. This project will likely consist of AOA gate access control upgrades (badge access only), fencing and access gates on the north and south ends of the commercial terminal ramp, and potentially a security fence along the airside perimeter of the Garmin AT Campus to move the entire facility outside of the AOA, except for aircraft access onto Taxiways Golf and Bravo.
