# INTRODUCTION

Secor Park is located on an 8.74-acre site in the Sunnyslope Neighborhood of south Salem. Classified as a neighborhood park, the site is owned and maintained by the City of Salem. The location of the park site, growing citizen interest, and existing natural resources all provide an excellent opportunity for the improvement of this park.

# SITE DESCRIPTION

Secor Park is bounded on the west, north, and south side by residential properties and on the east side by Crossler Middle School. The north entrance to the park is located off of Rock Creek Drive while the south entrance is located off of Stockton Avenue. A narrow portion of the property extends east, including two access easements, that will be considered as a future park connection to Liberty Road. There is an existing network of unpaved, mulched pathways that wind throughout the park and a series of unpaved, informal pathways throughout the woodlands. The site is bisected by Waln Creek, a subwatershed of the larger Battle Creek Watershed. The creek flows east on the site, entering from the west and existing through a culvert at the east end of the park. There are currently two creek crossings, a wooden bridge on the west side of the park and a culvert in the middle portion of the park. A woodland and open grass areas compose the major vegetative communities of the site. The woodland consists of mostly Oregon White Oak, Oregon Ash and Doug Fir while a dense underbrush is predominantly composed of invasive Himalayan Blackberry and English Ivy. Additionally, existing camas patches are located along the south side Waln Creek.

### **SITE HISTORY**


Prior to the development of the Sunnyslope
Neighborhood, the park site contained a farm that was
estimated to be several hundred acres in size. Oscar
Dencer and his brothers established a farm that held
fruit and nut growing operations that included prunes,
cherries, walnuts and filberts. Oscar Dencer constructed
his home and other buildings on the park site, including
a prune dryer. In 1946, Ralph Secor acquired forty-two
acres of Oscars Dencer's farm that included what is
now Secor Park. In 1977, Mr. Secor chose for a portion
of his property to be converted into a park. The Salem
Open Area Recreation (SOAR), a non-profit working to
acquire park land, purchased approximately 10.2 acres
of the Secor property. In 1980, the Salem City Council

officially designated the new park as "Secor Park". In 1995, the first master plan for Secor Park was developed by the City of Salem. Throughout the design process the City gained input from the Sunnyslope Neighborhood Association to develop design suggestions for the plan.

The primary goals of the original master plan were to preserve as much of the site's natural features as possible, improve access to the park, provide a diversity of amenities, restore Waln Creek to improve water quality, and provide minor lighting along the pathway system.

# SITE ASSESSMENT AND ANALYSIS





#### **OPPORTUNITIES AND CONSTRAINTS**


The park currently provides a diversity of undeveloped amenities including a mature woodland forest, a perennial stream, and gently sloped grass areas. There are two formal access points to the site and several informal connections to the running track at Crossler Middle School. The entrance at the north side of the site connects to Rock Creek Drive via a narrow, unmarked pedestrian way making it difficult to find and suggests that it is a minor entrance. The entrance on the south side of the site comes off of Stockton Drive, a residential street with sidewalks on either side. The openness of the entrance, in addition to ease of access, suggests this serve as the major entrance. The park itself, however, only has a mulch pathway system and does not currently meet ADA accessibility standards thus is not accessible to all users. The existing mulch pathway is heavily used and suggests an ideal location for a paved path. There are two types of informal, unmaintained pathways within the wooded area: Type 1 is a well worn dirt path while Type 2 is a narrow pathway with obstacles. Along

the existing pathway network are several areas with large open grass areas, gentle slopes, and southern sun exposure. There is also an open grass area at the northern portion of the site where the existing grade is higher and provides a view out to the creek and to the adjacent ball fields. These open grass areas are most suitable for future park amenities. A 50'-stream buffer is set along both sides of Waln Creek and proposed amenities within it, other than a path network, should be avoided.




Existing mulch trail path. Image Source: City of Salem.


Q4: Below is a list of elements included in the Secor Park Master Plan, completed in 1995. What is your opinion about adding these to the park?




Q6: If you had to select only one park element (any element) to add, what would it be? This item may be from the lists included in previous questions or could be something else. (Write In)

Selection of survey results presented at First Public Workshop (04.03.2019)

#### FIRST COMMUNITY SURVEY

In March 2019, the City of Salem Public Works
Department administered a neighborhood-focused
public survey to obtain feedback on park development
priorities and preferences. To advertise the survey, an
invitation was distributed in multiple ways, including
online notices, posters placed at park entrances, flyers
circulated through community-based organizations, and
by emails to subscribers to the project email list service.
The Sunnyslope Neighborhood Association and City
communication staff were encouraged to post notices
on social media as a means to further advertise the
opportunity to participate in the survey.

The survey was conducted as part of the public involvement program for Secor Park. The City of Salem and Lango Hansen Landscape Architects used survey responses to gauge reactions to the 1995 master plan, potential park features and uses, to solicit suggestions and ideas, and learn about present day park uses and issues. The survey was composed of fourteen questions, all of which were optional. The City received a total of 88 completed or partially completed responses, which were used to generate initial design concepts.

#### FIRST PUBLIC WORKSHOP

On April 03, 2019 the first public meeting was held at Crossler Middle School. The Sunnyslope Neighborhood Association and the City of Salem assisted in organizing the workshop. Lango Hansen presented the first survey results, site inventory and analysis, and three design concepts, including precedent imagery. Colored dots were administered to the public in order to gain feedback about their preferred design concept and preferred imagery. For the concept plans, each person was given red, green, and yellow dots: red represented their least preferred option, green represented their most preferred option, and yellow represented their moderately preferred option. Participants were also given three blue dots each and were asked to place on their favorite images. There was no limit to how many blue dots could be placed on any image. Specific comments about the three options were also recorded by the City of Salem and Lango Hansen.



# **CONCEPT PLAN - OPTION 1**

The initial options were composed to provide a range of development options, from less developed to more developed. Each option provided different alignments for a mulch trail, paved trail and a range of programmatic elements. As the current culvert crossing is not ADA accessible, each option proposed a new, accessible bridge crossing at that location. The concepts also depicted ecological enhancements such as a pollinator garden, woodland and stream restoration.

The first option used minimal interventions across the park and was somewhat similar to the 1995 master plan. A paved pathway connected the north and south entrances, then looped through the western portion of the site. Two connections were provided to the Crossler Middle School track. Entry plazas were proposed at the north and south entrances and would

contain park signage, bike parking, and a community kiosk. The play area was located at the north side of the site to take advantage of shade provided by existing trees and views out to the east portion of the site. A picnic area was located on the south side of the site where there is a gently sloping open grass area. Bench seating and interpretive signage were placed in multiple locations along the paved pathway.

The feedback received from the public for this option indicated that this was the least preferred, primarily due to its simplicity and lack of elements. The images most favored by the public were the bench seating and natural restoration elements, such as the pollinator garden, woodland and stream restoration.



# **CONCEPT PLAN - OPTION 2**

The second option depicted the most development of all three concepts. A paved pathway again connected the north and south entrances with a plaza provided at each end. Both plazas included park signage, bike parking, and a series of lighting along the central pathway. Both a picnic shelter and basketball court were proposed at the north plaza. A paved pathway looped around the north half of Waln Creek and connected at the east side to the running track at Crossler Middle School. Several connections were provided into the woodland area where a new unpaved path system was located. Benches and interpretive signage were provided throughout. A play area, picnic area, and community garden were located on the south side of the site to take advantage of gently sloping open areas and southern exposure. An additional bridge crossing was also proposed.

The public feedback indicated that this was the most preferred option, particularly due to the layout of the pathways and diversity of proposed elements. However, the basketball court was the least preferred program element due to noise and proximity to an existing court at Crossler Middle School. The location of the play area and community garden was favored by the public due to visibility from the street and from the adjacent baseball field. The addition of a bridge crossing was well-received but given the size of the park, it was determined that only two bridge crossings would be necessary. Of the images presented with this option, the picnic shelter and slide images were most well received.



# **CONCEPT PLAN - OPTION 3**

The third option was a hybrid of the first and second concepts. A play area, entrance plaza and picnic area were provided on the north side of the site. On the south side of the site an entrance plaza, community garden and a picnic area were proposed. Lighting was proposed only at the two entry plazas. A paved pathway connected the north and south side of the site and a larger looped paved path traversed the western portion of the site and connected to the Crossler Middle School running track. A small mulch trail provided access to the interior of the woodland while a second mulch trail meandered along the north side of Waln Creek. A wetland demonstration component was proposed at

the existing culvert on the east side of the site, including an informal outdoor classroom. Benches and interpretive signage were provided along the trail network.

While this option received generally positive input, it was the second most favored option of the three plans. The public viewed the provision of two picnic areas on each side of Waln Creek and the more discrete approach to lighting as positive elements. The public reacted positively to the images of the play area, community garden, and the proposed bridge crossing.

# **SECOND COMMUNITY SURVEY**

In April 2019, a second survey was administered by the City. The survey included the three options presented at the first public workshop and a series of questions intended to measure respondents' preferences and reactions to the concepts. The intent of the survey was to provide an opportunity for those who were not able to attend the workshop to provide feedback and allow those in attendance to provide additional feedback. The survey included 10 questions and received a total of 48 completed or partially completed responses. The feedback gathered through the survey aided in the development of a single design concept for the park.

# **SECOND PUBLIC WORKSHOP**

Following the first public workshop Lango Hansen incorporated the feedback from the meeting, online surveys, and feedback from the City to create one refined park design concept. A cost estimate was also generated to help asses park priorities based on available funds. The second public workshop on May 15th, 2019 included a recap of the first public meeting and a presentation of a draft Master Plan, including the draft concept plan and precedent imagery.

# **MASTER PLAN**

The final master plan for Secor Park synthesizes input from the public and the City along with what was indicated by the opportunities and constraints of the site to create a unified scheme.

The main entrance is proposed at Stockton Avenue, where an entry plaza is located. The plaza includes a park entry sign, bike parking, community kiosk, site light, and seat wall to welcome users. Bollards are included to prevent unwanted vehicular traffic from entering the site. A community garden is located to the east of the plaza to take advantage of the southern sun exposure. To the west of the entry plaza is the play area with accompanying water fountain, benches, and picnic area. A 10-foot wide concrete path connects the north and south entrance, crossing Waln Creek at approximately where the existing culvert is located.

As the existing crossing is not ADA accessible, a new bridge crossing is proposed. The pathway continues to the north entry where a small entry plaza with an entry sign, seating, site light, and ornamental planting are provided. A picnic shelter is located east of the plaza, sited to take advantage of the gentle slopes and view down to the creek and adjacent middle school. A second picnic area is located west of the smaller plaza while even further west a pollinator garden is proposed.

A series of 6-foot wide paved pathways and 4-foot wide mulch pathways traverse the site in tandem with the main pathway to create a series of walking loops. A number of benches and interpretive signage are provided throughout. Enhancement of the woodland area and Waln Creek will be accomplished through the removal of invasive species and the planting of native vegetation.

# PRECEDENT IMAGERY

Image boards of possible play elements, plant material and site furnishings were also presented to illustrate what material could be incorporated into the park.

The first grouping of images depicted different styles of play: modern, traditional and nature play. A second grouping of images highlighted specific types of play equipment categorized by type: swing, slide, climb and spin. Adhesive colored dots were given to the public in order to gain feedback about their preferred style of playground and individual play components. The most preferred style of playground was nature play while modern was the least preferred. In general, the images with climbing and spinning elements were received most positively.

For plant material, three categories of plant types - woodland, riparian and pollinator - were presented to the public to illustrate a sampling of a plant palette suitable for the site. The plants shown were all chosen for their ecological benefits and being native to Oregon.

The final board showed a range of typical park furnishings that included those found throughout City of Salem parks and ones that would be unique to Secor Park. While the City of Salem does not have specific site furnishing standards, the goal is to provide a balance between the maintenance requirements of the park while helping to create a unique sense of place.

# **NEXT STEPS**

The City of Salem does not have the financial resources to complete development of Secor Park all at once. Design and construction of park features will be phased. A first phase of development will proceed within one to two years, and is likely to include entry plazas, the playground, a picnic area, 10-foot wide paved path, and site furnishings. A later phase could include all other elements not included within Phase 1.


Some master plan elements may proceed outside of phasing through volunteer efforts and management practices. This could include invasive plant removal, woodland restoration, and development of the proposed pollinator garden and community garden. Riparian restoration may also be advanced by the City as a separate stormwater management project.




Play Image Board from Second Public Workshop (05.15.2019)

# RESULTS FROM SECOR PARK SURVEY #1: INPUT OF PARK PRIORITIES

# **Survey Overview**

Secor Park is an approximately 8.5-acre, undeveloped neighborhood park located in the Sunnyslope Neighborhood. In order to obtain feedback on park development priorities and preferences the City of Salem Public Works Department administered a neighborhood-focused public survey from March 1, 2019 to April 4, 2019.

The survey was conducted as part of the public involvement program for the Secor Park Improvement Project. Park Planning staff and the project consultants used survey responses to gauge reactions to potential park features and uses, to solicit suggestions and ideas, and learn about present day park uses and issues. While administered primarily in an online format, City staff offered a hard-copy version upon request. The survey was composed of fourteen questions. All question responses were optional – respondents were able to skip any question that they did not want to answer. The City received a total of 88 completed or partially completed responses.

The project team invited participation in the survey as part of initial project outreach. Outreach methods were comprised of posters placed at park entrances, distributing flyers to community-based organizations including the Sunnyslope Neighborhood Association, mailing postcards to addresses within a half mile of the park, and publishing a news feature on Cityofsalem.net. Additionally, Park Planning staff made request to the Sunnyslope Neighborhood Association and the City communication staff to post notices on social media as a means of further inviting participation.

# SECOR PARK SURVEY #2: FEEDBACK ON INITIAL DESIGN CONCEPTS

#### **Survey Overview**

Secor Park is an approximately 8.5-acre, undeveloped park located in the Sunnyslope Neighborhood. As part of the Secor Park Improvement Project, the City of Salem implemented two neighborhood-focused public surveys to involve the public in planning for improvements to the site. The second survey was administered from April 4, 2019 to April 17, 2019. It presented three conceptual design options for the park.

The survey was administered in an online format and included 10 questions to gauge respondents' preferences and reactions to park features presented in the three separate designs. An option to complete a hard-copy version was offered upon request. All question responses were optional – respondents were able to skip any question that they did not want to answer. A total of 48 completed or partially completed responses were received. The project team used feedback provided by the survey to prepare a single draft design concept for the project.

To advertise the survey, an invitation was included in public outreach for the project. This invitation was distributed in multiple ways, including notices on Cityofsalem.net, posters placed at park entrances, flyers distributed to community-based organizations including the Sunnyslope Neighborhood Association and by emails to individuals subscribed to the project email list service. The Sunnyslope Neighborhood Association and the City communication staff were requested to post notices on social media as a means of further advertise the opportunity to participate in the survey.





A small loop or something from Stockton could be extended into the park to accommodate say maybe ten cars and the picnic shelter and picnic area could be swapped to make it more useful.
9	There is no need for a baseball court. Residents have used the Crossler courts for years. Save the green space.
10	I was not sure if the pictures showed the actual plans for the play area, but I absolutely vote for a natural-type play area (similar to the one at Champoeg) with logs, sand, water features and other similar nature-based features for kids to enjoy.
11	More nature, less play area. A place people can go and have some contact with the natural elements.
12	Instead of, or in addition to the basketball court, I suggest an area with some pickle ball courts. Its gaining popularity and there aren't any good outdoor courts in south Salem. I think it would get more use than other options (e.g. basketball, volleyball, tennis)
13	The lighting at Stockton Ave is not necessary, and will cost more money over the long run. Please respect the fenced oaks, we saved them from the mowers and they're really thriving now. Lastly, please work with the Marion Soil and Water Conservation District as they observed endangered birds in this park in 2012.
14	The students at Crossler will be large users of this park. Trails with lights, wooded area with refurbished streams.
15	Please don't buy extravagant playground equipment. Stick with the basics. Swings, slides and things to climb and lots of them.
