- Committee Chair Update
  - Houseless Update
    - As of 9.7.23
      - The City of Salem is beginning on Monday an audit of the work the city has been doing in the homelessness space. Consultants are gathering information to study the work and we would have a report in Spring after the 6-7 months process.
      - At this time, we are concerned about budget for several areas – the upcoming warming activation is not funded at the level it has been (the city retained the same funding level, but state funding has shifted and at this time funding is still being sought to augment the warming work this winter), and the two currently operating microshelters and the safe park program don't have city grant funding identified beginning July 1. City staff are at work to identify alternative funding sources. The city is going to be encouraging volunteerism in the warming network; if the

- funding levels remain low, increased volunteers could very tangibly increase shelter beds to needed numbers.
- Polk County is at work to hire 'qualified mental health professionals' to help expand their behavioral outreach mobile crisis services in Polk County – they would be a non-law enforcement team that would respond wherever a person is experiencing behavioral health crisis.
- The City of Salem continues spending a lot of time working with people at Wallace Marine Park, providing outreach and information and removing garbage. There is a lot here to do and we are working on different ideas or approaches that can help. We are working strategically to help people access different options and work to reduce the number of those living at the park.
- Renovations are underway at Safe Sleep United, a low-barrier, non-denominational overnight shelter for women, which is in its third year of operation. The expansion will allow them to shelter 50 women, up from the current 19.
- Data shows that over the past year, the shelters sent 82% of families and 56% of adults to better destinations, which could include permanent housing, transitional housing, inpatient treatment, detox, or other care facilities.

## • Titan Hill Development Appeal

- Discussion took place on our appeal and how it was denied and what our next steps are going forward. The group had a very long discussion and at the end we voted not to move forward on this issue any longer.
- Next scheduled meeting is Oct. 5 starting at 6:30PM
  - Special note we have moved our starting time by a half hour to attempt to have more people in attendance.
