A Class 3 Major Historic Design review of a proposal to replace eight windows and siding on the exterior of the Bishop House (1938), a historic contributing building in the Gaiety Hill/Bush's Pasture Park Historic District in the RS (Single Family Residential) zone, and located at 460 Leslie Street - 97301 (Marion County Assessor Map and Tax Lot Number: 073W27CA00500).
