- Introduced Jennifer Biberston, new Administrative Analyst who will be staffing the Planning Commission.
- No public hearings scheduled for the September 5, 2023 Planning Commission meeting, a potential cancellation email will go out for Commissioner items.
- The code amendment resolution that was initiated tonight is on the tentative schedule for the September 19, 2023 Planning Commission meeting.
- City Council deliberated on an appealed land use decision at the August 14, 2023 meeting and affirmed staff's decision.

10. COMMISSIONER COMMENTS FOR THE GOOD OF THE ORDER:

- Commissioner Eachus mentioned that the Salem Heights improvement plan was approved at City Council and slated to be included in transportation systems plan.
- Commissioner Goebel mentioned that there are areas of the development code that need to be reviewed, it seems like there are some overly complicated sections, especially when it comes to determining things like setbacks.
- Commissioner Slater mentioned the energy subcommittee has reached out to Portland General Electric, and have asked that they do a presentation on what they plan to do. They have not heard back yet, and hope to have them here by the end of the year.
- Commissioner Fought mentioned the importance of Climate Friendly and Equitable Communities and ensuring we have sustainable strategies when it comes to development.
- Commissioner Eachus mentioned that he attended the August 14, 2023 City Council
 meeting, and brought up the use of the language "no reasonable alternatives" as a
 supplied finding from Applicants on land use cases. The fact that there are 63
 conditions of approval and not enough input from public, how can this be improved
 during the land use process in the future?
 - Ms. Anderson-Ogilvie answered that there was a code amendment last year that defines what "reasonable alternatives" mean. The case that Commissioner Eachus is describing did not include an application type that uses reasonable alternative analysis. It is getting harder for staff to deny applications that would bring more housing to Salem because of State Law.
- Commissioner Heller thanked staff for the presentations tonight.
