

Re: Rate Subsidy Discussion



Commodities have evolved over the last several decades in Salem. These include yard debris, which is now known as the mixed organics cart with the addition of kitchen scraps to the mix in 2010 and mixed recycling which includes the small glass bin. These differing waste streams and their relationship with garbage collection have impacted the rates over the years. When recycling was first introduced, the impacts were positive, and the sale of material was able to offset cost and operational increases. Since China's implementation of "National Sword" in 2018, the cost of collecting recyclable material has added to the cost of garbage service, at times costing more per ton than garbage. This is still a volatile market. While the cost of mixed organics has always been included in the residential service rate, the portion associated with mixed organics has been less than that of garbage. Both mixed recycling and mixed organics carts give customers options to dispose of material that would otherwise be landfilled or incinerated and lower the customer's bill. Both cost savings have worked through our cost-ofservice structure to make sure the customer is the direct beneficiary.

Customer accounts are generally categorized as either commercial (container) or residential (cart) customers and are often thought of as single-family homes and businesses. However, commercial accounts are made up of multi-family customers that use container and many small businesses use carts. Pushing cost burden to the commercial line of business will directly affect the equality of rate setting and could drive the cost of rent up across the City of Salem.

Service levels are generally looked at from the garbage cart or container size and little consideration is given to the standard package including all bins. The goal is for each customer to have the right size garbage container to compliment the recoverable materials they can divert out of the garbage can. If a subsidy were put in place that favors residential service by increasing commercial service rates, the rate variance between residential service levels would

decrease reducing the incentive to downsize residential garbage service – counterproductive to the goals the city has set forth.
