Notice of 30-Day Public Comment Period and Public Hearing for Program Year 2022 Consolidated Annual Performance and Evaluation Report (CAPER) and Program Year 2024 Annual Action Plan (AAP)

The City of Salem Urban Development Department is making the 2022 CAPER and 2024 AAP available for public review and comment for 30 days beginning on March 21, 2024, and ending on April 18, 2024.

The CAPER describes how the City's grant funds from the US Housing and Urban Development (HUD) were expended from July 1, 2022, to June 30, 2023, to carry out the housing, homeless and community development objectives, strategies and activities outlined in the City's 2022 Annual Action Plan and any substantial amendments. The AAP describes how the City intends to spend its grant funds in the upcoming year, July 1, 2024, to June 30, 2025.

The Program Year 2024 AAP proposes the following allocations:

CDBG \$1,315,040

- Garten Services, Inc.: \$34,392 for building rehabilitation and fire safety
- WestCare Oregon, Inc.: \$400,000 for building rehabilitation
- Northwest Human Services, Inc.: \$38,160 for HOST Youth case management
- St. Francis Shelter: \$85,000 for family shelter case management
- Center for Hope and Safety: \$100,000 for services to victims of domestic and sexual violence
- Land Acquisition and Infrastructure: \$394,480
- CDBG admin: \$263,008

HOME \$997,300

- Micronesian Islander Community: \$600,000 for building affordable housing
- HOME CHDO operating: \$50,000
- HOME admin: \$99,730
- Balance: \$247,570 for future projects
