## **Call to Order**

The Task Force members unanimously voted to amend the minutes taken at the March 18, 2024 meeting.

## **Community Survey Results**

John Horvick, Senior Vice President at DHM Research, presented the results of the community survey. The Revenue Task Force was provided a copy of <u>City of Salem Funding Survey - Final</u>. The purpose of the survey was to assess the community's current understanding of Salem's revenue standing, service priorities, and preferences for various funding mechanisms and scenarios. The Task Force Members generated the following questions:

- Do the respondents know what a specific service one would pay for from the City?
- Does this [respondents favoring taxes levied on businesses] tie us back to the idea that people don't know what they're talking about?
- Do you think that people understood that things like police, fire, parks, library; there's no way to charge a user fee?
- Are you comfortable with the sample size for the survey for the population size of the City of Salem?
- Would you have preferred the sample size would have been larger to encompass more of the population of Salem?
- With 3% of the surveys being in Spanish, how does that compare to the percentage of Spanish speakers within the Latino population that we have; do you feel that's representative?
- For communities like Salem around the country during the last two years do you know if these [satisfaction with policing and code enforcement] trend lines have continued?

#### **Townhall Results**

Results of community feedback from the April Townhall sessions were shared with the Revenue Task Force. The Moss Adams team responded to the following questions from Task Force members.

- What was the purpose of not giving them information or context [of how user fees work]?
- Would that [ambulance/emergency medical response) be a user fee that the City of Salem would then start charging when it takes over the ambulance service?
- Are we limiting ourselves to general fund or are we able to make recommendations for a levy or a special district that just focuses on specific services or programs that are not part of the general fund?
- Can you clarify what the deficit in the transportation fund means?

#### **Review of Revenue Options**

Moss Adams began presenting an analysis of the high-interest revenue options. Options presented included the Local Option Property Tax Levy, Business License Fees, and Personal Income Tax.

Member Russ Beaton shared a forecast of total income taxes and rates that could potentially be raised as a revenue source based on 2021 data from the Oregon Department of Revenue.
