Police Report, Salem Police Department. Sgt. McFerron, SPD

Department staffing: Budgets; We lost 4 spots. We have added 19 officers in 2023.

Q: How long until we see them here: A: Up to 18 months.

Police Academy. Fall and Spring. A look behind the curtain. 9 week commitment and 4 Saturdays. Try the Get involved section in the SPB website.

Community Violence town hall. 6-7:30 PM meeting on the 6th.

Q: Stationary cars: A:Code Enforcement.

Q: Something new: Mass search of open cars. A: That is the first we've heard of that in mass.

Reminder: Lock you car, do not leave bags or products. Don't be a target.

### City Council Update - Not attending tonight due to schedule conflicts.

Program: Marissa Theve: From Grant Neighborhood Association. Quiet, Clean Salem - Noise in our Neighborhoods.

Gas Powered Lawn Equipment and the noise associated with them.

Leaf Blowing: It's a Nuisance. 115 db for gas ones, 65 db for electric units.

Q: How loud can they be and not be illegal? A: We control noise at night, not during the day.

Loud Noise is a source of stress. There are physical effects to this.

These gas engines produce a lot of pollution. An F-150 pickup truck produces 1000 times less pollution than the small gas engines.

ROI from gas to Electric: 9.7 months. Q: Is that across the board? A: Yes.

commercial units. Paid back in less than a year.

Seattle and Portland both have this in process.

States are looking at possible buy-backs for older equipment. New York and Maryland have this now.

Q: It's a good thing. A: Yes. This improves lives.

Q: Do we have an example? A: Not in Salem. Yet. We are talking to them. The ROI makes sense to owners, but it's change.

See FAQ and potential endorsement. To be revisited.

Q: What is the blow-back on this from industry. A: Agreed the business case is Quiet first. The EPA has constraints on this and that's why we are starting here.

Lots of dialogue about the potential health hazards related to this.

#### Land Use Update & Reports, John Latimer, Land Use Chair

John is in Portland: Item #1: Sean will be in next month. Possible development west of Mock Orange/Heath area. 20 Acre parcel. Possible 100 units on this parcel. We'd like to see plans before commenting. Possible run-off issues.

ADU on Croisan Creek Road. We are seeing construction. The ADU looks to be being constructed in front of the existing home. Possible request for variance due to this. More things to look at in the coming months. Croisan Mountain Road. Has significant Oaks on it. Let's look at alternatives. We will weigh in on that. Conversation about tree diameter rules.

Punch List for possible Bond work: Request a Crosswalk and signage at Schurman and Crestview Lot's of kids going to school. School buses pick up here. Speed Cushions as suggested on Homestead road. Could we use a solution on Crestview. Railing on Madrona over Croisan Creek. Prospect place, south of Holiday drive. Missing 30 feet of sidewalk, Near the school. Speed Cushions on Homestead Road. We are submitting these.
