Airport Manager's Report – July 17, 2019

Current Project Updates

- Commercial Terminal Apron Rehabilitation: Awaiting grant award for \$1.2M which is
 expected by the end of July. It now appears likely that this project can occur in late
 summer/early fall 2019. We have already been granted an ODA COAR grant of \$100,000
 to assist with the required local match of \$133,000.
- 2. Pavement Maintenance: Significant amounts of crack-seal work, joint repair and some small asphalt reconstruct will occur late this summer under the Dept. of Aviation's Pavement Maintenance Program, utilizing a combination of State and Airport funds totaling approx. \$110k. Most of the crack seal work will be on RWY 16/34 and Taxiway "A" but also on several other taxiways and taxi lanes around the airport. Closure notifications will be made once the dates have been locked in.
- 3. RWY 16/34 PAPI Analysis: The final PAPI analysis was received and shared internally with the City's Dept. Directors and City Manager. The decision was made to proceed with the next recommended steps, which are to secure a tree survey consultant to provide an actual on-site tree count and then update the cost estimates accordingly. That process in underway, and once that is completed then the City's management team will review and determine the next course of action.

Airport Business Plan

The first draft version was received on July 5 for internal review. Future drafts will be sent out for review later this summer/fall, which will include AAC review. We hope to have the final version done by the end of the calendar year.

Hangar Use

Approximately 80% of hangar owners returned their information forms as requested. There are still a few trickling in based on recent hangar sales and such. Later this summer hangar inspections will begin in earnest for those that have not responded.

Air Service Development

The federal Small Community Air Service Development (SCASD) grant application was submitted the week of July 8th, in advance of the July 15th deadline. The application was asking for \$750,000 and we expect to hear about award notifications around the end of this calendar year. The federal money, if awarded, will go along with the local pledges of nearly \$650,000 and the State of Oregon grant of \$500,000 in an overall effort to attract air service to Salem. No additional airline meetings have yet been scheduled.

USDA (and other) FOD Issue

The USDA Wildlife Services contractor that assist us with our Wildlife Hazard Management Program have been doing a much better job of policing up after themselves in terms of stray shotgun shells and bullet casings. However, USDA and airport staff continue to pick up significant amounts of FOD from other areas around the airport, including ramps, taxiways and both runways. Most of what is being found is likely pilot-related FOD. The attached photo is a sample of what was located in the past couple of years, and that does not include trash bags, paper cups and other debris that makes its way onto the airfield. Please remind yourselves, your tenants, and your hangar neighbors that FOD is everyone's problem and safety is everyone's responsibility.

Warbirds Over the West

The B-17 Alliance Foundation is hosting its annual Warbirds Over the West event for August 10 & 11. Last year's Friday/Saturday event was not as well-attended as in past years so this year they have moved it back to a Saturday/Sunday event.
