July 27, 2021 meeting minutes, 7 pm.

I also told them that I will need help getting everything to the park that night about 3pm to 4pm and set up for National Night on the 8/3. The Mayor and police will be coming along with Pastor John from the Baptist church and Joyce, Virginia's sister, and other family members. The party will be from 5pm to 7pm, but we start the speeches at 6pm. We will decorate the new bench at this time. Afterwards we will serve cake and water and give out gifts. I will buy stuff for the children, chalk, and bubbles, etc. I will tie balloons around the park, bring my canopy, tables, and signs. Irma Dowd, City of Salem will attend and bring information to the neighbors as will. We hope it will not be to hot and be well attended.

We talked about the black trailer parked on the corner of Lansing and Hammel and if we should report it to the City, because it is blocking driving going into Hammel and out of Hammel. It was agreed we should call the City, and I will do it.

We also talked about school starting soon and our concern for the children and families from the apartments at Willow tree on Silverton and Lansing Rd. We think there should be a crossing guard there to make sure they all cross safely, I would like to talk to Salem-Keizer school board, but not sure when they meet to request this. We thought this might be the way to go about this.

I did talk about the homeless and that I have gotten a lot of emails on this by other chairs. I know that the City did clear the homeless from under the I-5 overpass at Market St, but we all know they will move elsewhere. There are no easy answers on this, and no one knows what to do about this problem. We also know the homeless are at city parks and other parts of the city as well.

I read an email from Oregon State Fair. This stated hour of business and the concerts schedule (letter attached). This is a yearly notice regarding noise from the fairgrounds from 8/27 to 9/6. We didn't pass anything but agreed that is was nice to let us know what was happening at this time.

There were no committee reports and no other concerns. The meeting was adjourned by Terry Pratt and seconded by Mary Dodson.

The permit includes the concert series at L.B. Day Amphitheatre, attached in the event schedule. We are again proposing that evening concerts start at 7:00 PM and conclude by 8:30 PM. The afternoon concert on Labor Day starts at 4:00 PM and concludes by 5:30 PM. This schedule has been in place since 2014 and is intended to limit any concert noise late into the evening.
