7:00 PM Meeting called to order by Eli Brody, NESCA Vice Chair.

### **1. Welcome, Introductions, Announcements, Approval of Minutes: Eli Brody**

Vice Chair Eli welcomed all in attendance on behalf of NESCA Chair Mike Beringer who was unable to be here this evening due to participating in CERT training. Teri provided a correction to last month's minutes, received from Bridget West, Principal of Hoover School. Information previously received from Bridget regarding classroom additions was changed to November or December 2021 for completion. A motion to approve the minutes as corrected for the September 17 meeting was made and seconded. Motion carried.

### **2. Police Officer Report: Officer Tangney**

- Officer Tangney invited everyone to stop by to see the good progress on the new police station.
- Salem PD is hiring officers for entry level and lateral positions. Interested candidates can get additional information about the hiring process on the department's web site.
- 14<sup>th</sup> Annual Halloween Dress Rehearsal is happening at City Hall on Saturday, October 26 between 4 PM and 6 PM.
- Saturday, October 26 is National Prescription Drug Take Back Day. Anyone needing to discard old or excess medications, can take them to the drop-off site at the Peace Plaza on Liberty Street at the bus turnout between the library and City Hall. Hours for collection are from 10 AM to 2 PM.
- SPD is working with various agencies in Marion County to provide mental health crisis teams for better psychiatric evaluations in the field. \*Pamphlet information attached.
- Other:
  - Question to Officer Tangney to determine if there has been any uptick in criminal activity around Thorpe Park. He didn't feel there had been. Transient issues seem to be somewhat better.
  - Problem Oriented Policing (POP) helps relieve patrol officers from needing to respond to questions and concerns from citizens that are not necessarily "criminal". Officer Tangney said this has been very helpful for officers.
  - Chris Hoy mentioned a problem house on Coral Avenue (behind Bi-Mart) that POP helped with by taking about 10 people out. The house was basically destroyed and was ultimately razed.
  - 1425 25<sup>th</sup> still appears to have the same people living there however the house is for sale which should eliminate any ongoing problems.
  - Shopping Carts: Public works will retrieve them if they are on public property. There is discussion on a possible ordinance to charge cart owners if they don't retrieve them.
  - Neighbor Dianne Wilke asked if Officer Tangney is aware of problems on Park Avenue. She said she had forgotten to lock her car one evening and it had been gone through. Nothing of value was taken but everything was out of the glovebox and strewn about. He wasn't aware of specific issues but reminded everyone to be sure to lock all doors.
  - There are 11 new Marion County deputies which has helped with the unincorporated areas in the Lancaster area.
  - As always, CALL if anyone sees something unusual, that looks out of place, or looks wrong.

### **3. Marion County Parole & Probation: Officer Wendy Bales and Officer Belle Cottrell.**

- As explained, their function is to track parolees, help provide program information, and maintain contact to help them stay on the right path. Sometimes that doesn't happen, but, that is always their goal. Their unit specializes in family units, working with DHS, to provide full service. They do home visits to ensure monitoring for the courts and parole board, also checking for health

concerns to determine if there's adequate food in the homes, if the children are going to school, etc. They will often work with the same people for several years, so they come to know them very well. The group they work with is at risk to reoffend but are not necessarily dangerous.

- There is a trend of more physical abuse which is concerning to everyone.
- There are 39 officers in multiple units.
- For reporting concerns, issues call the main office at 503-588-8492.

#### **4. City Councilors' Report: Chris Hoy**

- The "Our Salem" workshop regarding the comprehensive plan and rules of development that citizens would like to see for Salem is being held tomorrow evening (10/16) at Pringle Hall from 6-8 PM and Thursday evening (10/17) at Crossler Middle School from 6-8 PM. The rules have not been rewritten for 20 years, so it is very important for everyone who has thoughts on how Salem should move forward in its development. A Spanish-only session will also be held at Chemeketa on Friday, 10/25. \*Flyer attached. There will also be a potluck with EnLace during the Friday session at Chemeketa.
- City Council Position. The open position for Ward 7 Councilor (resulting from the resignation of Sally Cook) will be filled by appointment of the council. Twelve candidates had submitted their interest in the position which has now been lowered to three: Reid Sund, Vanessa Nordyke, and Bonnie Heitsch. Candidates will be interviewed next Monday and the one selected will be sworn in in 2 weeks.
- Flood Plain rules were amended in order to allow residents to get reduced rates for flood insurance. No areas of NESCA are in a flood plain.
- Fisher Road is nearly complete. The poles have been received and the project is on schedule. Without any further delays, it should be done by mid-month.
- McKay Park will have a ribbon cutting ceremony at 4 PM on October 22. This project to update and renew the park has been 6 years in the making!
- The Brown Road project, connecting Silverton and Sunnyview, will be completed in mid-November.
- "Make A Difference Day" will be October 26, 2019. Beginning at 10 AM there will be planting of Memorial Trees in honor of Virginia Barker (who worked on the En Vision plan for NESCA/Lansing) and for Trinity Watt, Makayla Tryon, and Madison Copobiano, local teenage girls who were recently killed in a car crash. \*Flyer with more information is attached.

- a. Land Use Ian Johnson
  - Ian was unable to attend this evening. No report.

- b. Transportation Julie Redden
  - Marilyn Mortiz called the city about the traffic counters on 23<sup>rd</sup> and Park Ave between D and Center. She was told there was concern about truck traffic resulting from the development due to the thickness (or lack of) pavement. D Street is only 3” but current code is 9”.
  - Julie also called about the traffic counters and will be getting data and a report.
- c. Parks Eli Brody
  - Eli said the parks are looking good. The city is doing a good job around the parks regarding crime, vandalism, and transients.
- d. Hoover School Liaison Teri Lupoli
  - Teri reported that all the collected school supplies were delivered to Hoover School on October 3.
- e. Watershed Gary Pullman
  - Gary said the goal is to increase our tree canopy.
  - NEN/NESCA Tree committee is currently reevaluating the walnut trees along D and Park.
  - There will also be a re-evaluation of how and where trees are planted in the city.
  - The rain garden looks good.
- f. Oregon State Hospital North Campus Ian Johnson
  - No report.

**7. Business - Other:**

- NESCA By-Laws
  - Review was tabled. We will discuss the issue at the next meeting in which Ian Johnson is able to attend. Possible changes include allowing the Board to “meet” and vote via email between regularly scheduled meetings.

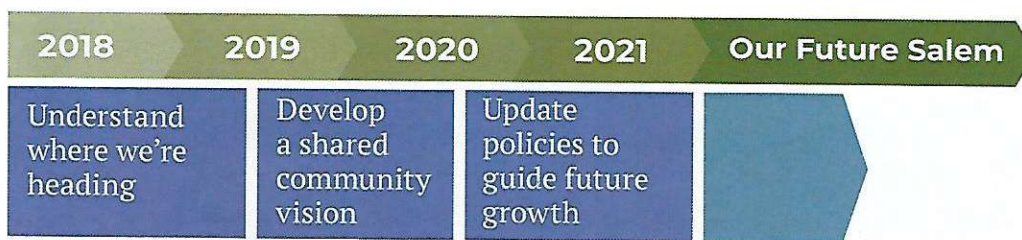

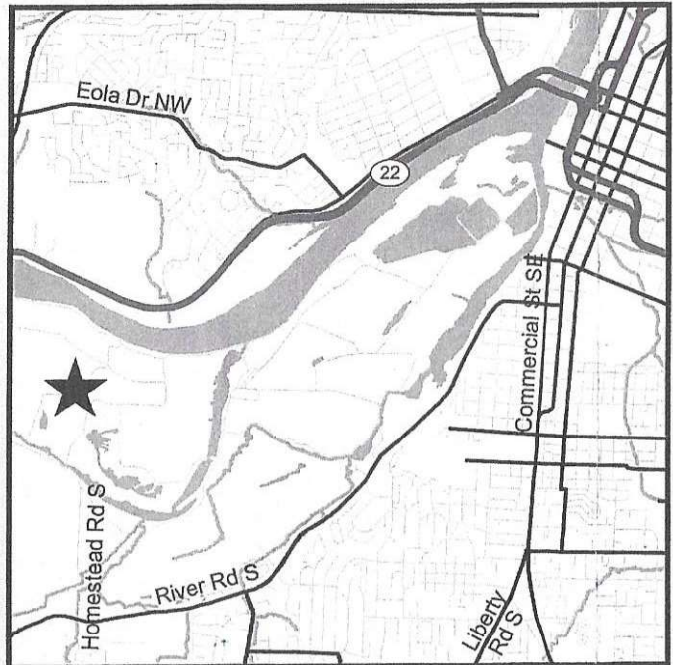

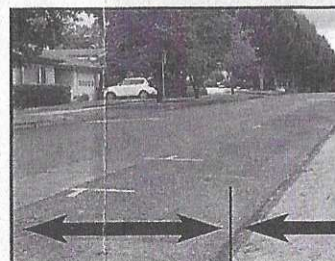
