1. WELCOME AND INTRODUCTIONS:

Mayor Bennett called the meeting to order at 7:02am.

2. AGENDA REVIEW AND MEETING #5 RECAP:

The Task Force briefly reviewed the agenda and the goal of this final meeting to reach consensus on the final project documents that will form the basis for the report to the City Council.

3. FINAL PROJECT DOCUMENTS

The Task Force reviewed the project draft Project Handout, Recommendations Table and Project Conclusions and Key Points.

Project Handout:

The Task Force reviewed the handout and made suggestions for additional clarification on traffic volume projects, problem statement, capacity and standards, regional context, and the considerations noted for longer-term options. The discussion of Short-Term Actions focused on the Recommendations Table.

Recommendations Table:

The Task Force reviewed the draft Recommendations Table and moved several items into the category of short-term actions, including variable speed limit signs; parking management; downtown circulator; park and walk/bike/shuttle at Wallace Marine Park; Taggart Dr/Wallace Road intersection modification; closing north crosswalk at Front St/Court St; improve signal timing/adaptive signal timing; improve incident management; construct Marine Drive; flexible work hours; multimodal/carpool incentives; bike/ped connections to Union St bridge; median/turn restrictions on Wallace Road, and future development planning.

Project Conclusions and Key Points:

The Task Force reviewed the document as modified from the August 3rd meeting. Primary changes were to items 4 and 5. The Task Force requested that item 4 on congestion pricing (tolling) be changed to emphasize the livability impacts that would result from such a program.

The Task Force expressed support for the project documents with modifications as discussed.

4. NEXT STEPS:

The Task Force requested that their report to the full Council would be best presented in a Work Session to be scheduled as soon as practical and that it was important that all Councilors be able to attend.
