Concern about a house on Court Street where there have been a number of police calls for domestic violence. Wants to know what the process is for creating a nuisance property. SPD - Process takes a while. After a number of calls are made the property owner is sent a bill to pay for police services. The District Officer will call the landlord. The can only arrest if the nature of the call involved "threatened, assaulted, or strangled" A release agreement will only be available with stipulations that they cannot go back. Concern about dangerous cross walks crosswalk in-between 25th and 17th. Cars do not stop. Discussion on the blinking light that coincides with Englewood School hours. Will work with school district to develop a better system. Virginia Stapleton worked on the Market Street Crossing. Concern about pedestrian fatality. No one wants to be the one killed or maimed. Use Citizen Complaint Form online or call. LT asked about support of police for sobering center. SPD - currently Salem hospital is being used for this. It is the busiest ER on the West Coast. This is very expensive. Arresting Intoxicated people uses resources and must be done with charging for a crime which creates another set of issues with court appearances, warrants etc. Sobering station - Contact Lt. Treven Upkes who is in charge of media. Concern about accident on 12th Street near Safeway where police cars stopped on the railroad tracks where the car accident occurred setting the stage for a potential train crash. It is very difficult for a train to stop right SPD - police notify Union Pacific Dispatch about the wreck and the location and the clear up time to avoid accidents. Rose St. Property Update. Enforces municipal traffic, DUII &

DWS. Court Appearances take a long time. Most inefficient court she practices

in. Concerned about police officers having over 3 hour waits. Large OT use for police officers and court clerks. Has run own practice for 8 years and believes time for a change. Concerned about mismanagement of fines and losing potential resources like traffic fines through inefficiency. Poor handling court dockets and fines. Wants to use more pro tem judges to increase speedy case. Survey described dissatisfaction with the court. Q & A: Gave explanation of how to create efficiencies. MP - Early Disposition- defendants should show up, work with attorney on this matter. Available at the court. Make it one stop shop. Fines are set by statute. Traffic violations are based upon a rubric. 21,000 misdemeanors and 3500 probations are handled through this court. Recycling Options at Event: pallets, tires, Furniture - Sparrow Furniture, Metal - Cherry City Metals, Swap area. TV's can be taken for free at the transfer station. This reduces injuries for helpers. No construction, household or anything with toxics will be allowed. City of Salem does not pay for clean ups so money collected from this event will need to applied to event pay to year Mey not get waiver of fee from Benyblic.

	Flyers: Lynn Takata Use double sided flyers to print info on clean up on one side and the Forest Festival on the Other Side. These would cost \$ 70. Ongoing concerns: Dumpster, placement of barricades for traffic flow, what entrances to be blocked, using of cones and barricades. Dumpster will handle only 2 cars at a time. 30 yd Dumpster will be 22 Feet Long by 11 feet wide and 6 feet high. A clean up meeting will be held to work on logistics.
