Discussion	Union Gospel Mission may move to a new location. Process has been initiated. Budget will be officially voted on. Sidewalks were again given a budget of \$1million with no extra money added. The same as last year. All the money was not spent. This generated some discussion as there were NEN members who have testified on this issue and are frustrated that many of the sidewalks that needed repair were not fixed. Discussion about the frustration about the number of accidents caused by the disrepair of the sidewalks and the slowness of the city's repair schedule. NEN approached CTEC for apprentice opportunities. Tom Reported that Salem is looking at implementing a plastic bag ban. Ordinance to be researched by city. Expect more on this issue later in the summer as the ordinance is drafted.

Discussion	See cityofSalem.net/police-station for information. Also updates on Facebook, You Tube and Twitter Designers: CB2 (Salem) & DLR (Portland). Builder GE Dune (Portland). Bond and Insurance Requirements high which limits builders. 1st floor – Public access: Lobby, community room, Sally Port which holds 3 cars. Plan for 24 parking places. 2ns floor- Patrol- lockers, showers. 3rd Floor: Investigation, narcotics, vice crimes, Crime Lab, Administration. Discussion on new features: separate victims from suspects; behavioral health team support and staffing; graffiti, location of the communications center, underground utilities, 2 story employee parking garage which also holds patrol cars, solar panels requirements with plans to use as cover for patrol vehicles. 24 parking spaces generated the most discussion. There may be some changes to the traffic patterns on Division and Liberty by converting the one way streets to two way. These changes would allow better access and possible more onsite parking. Parking will be heavily patrolled and regulated. It will provide more parking than is currently avialble to the citizens

Alan Scott discussed the issue of pedestrian safety particularly in crosswalks marked and unmarked. Perception that enforcement is only done when the department gets grants. Discussed the issue of drovers who are not paying attention. Identified 4 areas with dangerous crossing for pedestrian in NEN: 17th& Nebraska, Marion & 13th, Market & 15th& Center and 21st. Pedestrian fatalities have been occurring at night. Often pedestrians are not seen. Cross walk stings often occur with notice and drivers still violate the rules. Pedestrians need to be careful as they will always loose.

Discussion	 Nancy McDaniel represented herself at the hearing. Outcome: Planning commission voted to eliminate the road diet and keep the wide sidewalks. Lower parking space requirements. Do away with the FRONT setbacks and standalone parking lots and drive-thrus are not permitted under the proposed ordinance. The State Street Plan will go before city council in July before it is adopted. Nancy McDaniel will submit new testimony. Place on agenda for future meeting and work on a draft letter for the council. Shade Study: 55 feet is lower than the current code allows. Parking lots and Drives through are in the draft language. Design Review on are near Court Street Footbridge. Incompatible with historic area. Withdrawn.
