Parking Impact Discussion: New Remodeling will increase capacity in enrollment for up to 2,200 students. They expect a 10 to 20 year phase in. School Design has reduced number of parking spots. Have been designing an education campaign for students about neighbor relations and parking. Problems: Parking has migrated to Nebraska which clogs that street. Discussion	Question to Salem Keizer Officials- Has there been any contact with the Urban Development for use of Marion Street Parkcade with a circular bus? Action Ideas to solve parking issues: Bus Pass Pilot Program, Parking Ordinance that allows towing for blocked driveways, Develop incentives to get parents and students out of their car. Budget: Updates on strategies to create revenue to cover expenses for shortfalls in the general fund which primarily covers police, fire, planning and library. General Fund is around \$120 million and the current projections		

are for \$ 8 million shortfall which translates into a loss of 65 police officers. Revenue task force is exploring other sources of revenue besides property tax: transportation fee, operating fee placed on the utility fee and an employee paid payroll tax. The first proposal is not feasible. The Utility fee proposals are: Single family household \$ 10 a month, Multi family \$ 8 a month and a \$ 30 fee on large scale irrigators. Employee paid tax will be on workers in Salem at .03%. Discussion reviewed support, implementation strategy as to whether it would be a council vote or ballot vote, its broad support in the community, the revenue fiscal problems which exist because the largest employer – the state cannot be taxed, the unfairness of expecting people on fixed incomes to pay more money to support the city, and the effect of a payroll tax on sole proprietorships. The council has not taken action on the proposals yet. They will ask neighborhood associations for support. If the tax proposals are placed on the ballot, implementation will not be enacted until 2021 so revenue shortfalls will continue. The reason for these shortfalls has to do with property tax Measures 5 & 7 which limits the amount of money that can be collected from property tax. This is a problem in many areas in Oregon.

The city of Salem's water is safe. Funding for a Rapid Flash Beacon at 13<sup>th</sup> & Marion, Union St. Bikeways Improvement.

Alan Scott shared Portland's towing ordinance with Councilor Kaser. where cars that block driveways can be towed immediately. NA is looking at this as a solution to clear blocked driveways where homeowners much wait or drive on their lawns to leave their homes. Councilor Kaser agreed to investigate and look at ways to make Salem's ordinance more functional.
