✓ Neighbor Concerns

Jacqueline Schindele noted that a resident had refused a sidewalk repair near her house citing that the city does not have an urban forester and Salem needs one. Discussion on the current process of removing street trees associated with the sidewalk repair on Chemeketa St. Current repairs are straight and go through roots. New sidewalks do not curve or contour with the roots. Research the criteria on sidewalk repairs with mature city trees. Tom Bradley is the person making decisions health and fate. Many decisions are based upon "professional judgment". Lynn Takata cited a tree removal associated with a sidewalk repair where the homeowner wanted to keep the tree. There may be some issues about easements. Contact Mark Bechtel and Tom Bradley for further policy decisions about sidewalk/ tree conflict decisions.

Discussion

Concern about hedge encroachment to the sidewalks. Contact code enforcement on line to make a complaint. Homeowner will be notified so they will be required to remediate or pay the city for their work.

Is it a policy to notify neighborhood association when a neighborhood watch is formed? Contact the police when comes to neighborhood meeting. Concern about the sidewalk closure 100 Commercial ST. NE that is long-term and has no alternative walkway set up at this location. People are forced to walk in the street. It appears that Salem's code does not have language. A similar situation occurred when Barracks Funeral Home was torn down and Starbucks was being built. Concern that Lions Club which is close by, has sight impaired people who use sidewalks who will be forced to walk in the road.
