details are not available. Cautions neighbors that the park in closed after dark and to not walk around in it. Have made arrests in Englewood Park.

Encourages neighbors to use the park during its open hours, be vigilant about activity and contact the police. Swing shift is very busy and the officers go on many calls. Possible neighbor solutions are neighborhood watch, register cameras on the SCRAM system. Some neighbors want to install security cameras in the park as a deterrent.

Discussed Salem gangs and the legal tools used to apprehend members.

Crime will generate arrests not being a member of a gang.

Low revenue has decreased the funds available for police support. City Councilors are looking at revenue solutions to pay for public safety because property tax revenue does not cover the costs. Chuck Bennett supports this effort and is concerned about public safety. Chaired the Revenue committee and has some solutions to generate funds. Email

✓ Chuck Bennett – Revenue Solutions

Property Tax limitations from the 1990's affect the funds for Salem. Property taxes were frozen at the rates. Corvallis and Eugene had higher rates. Eugene is the same size as Salem but initially had a higher tax rate.

Kicker tax is also a source of limitations which is based upon returning money for poor economic forecasting.

Discussion

Looking at an employee tax which will be administered by the Department of Revenue and an operating fee.

Police Station overruns have meant changes in features. Project is still on budget. When the price of 300 sq. ft went to 400 per sq. ft. adjustments were made. Building is being paid by bond and urban renewal funds. Articles in the paper do not mention this fact.

City Councilor Report –Cara Kaser(CK) – present; Tom Andersen (TA) -present

Discussion

Refer the payroll tax to the voters. People making under \$25,000 will be exempt. Graduated tax. People making over \$50,000 will pay \$ 150 a year. Operating Fee will be added to the water bill. Voters need to decide what type of community they want to live in? Will discuss Sept. 23.

Expect another sidewalk behavior ordinance to spear. Criteria will be on behaviors not status.

OUR Salem is having a public meeting in October. Check the website for dates.

McMahan's Property being redeveloped with KOZ funds. Salem Housing Authority has ability to work out tax rebates for developing affordable housing units. Concern that the Housing vouchers are frozen and there is not enough affordable housing for residents.
