Police and Compliance reports from City: Packages left on front porches have a risk of being stolen. Cars with packages or any belonging lying on a seat or in view are enticing for car thieves. Keep belongs out of view and doors locked. Have someone retrieve packages from porch if you are not going to be home. Car accidents increase when it rains so please drive slower and pay attention to your surroundings. If you see graffiti call 503-371-42674 to report. The compliance Officer Gonzales gave report of the efforts to remove abandoned vehicles, illegal camping including campers on the streets and in public parks, the garbage dumped on roadsides. For abandon vehicles call ODOT: 503-362-0457 OSP: 503-378-8387,

Five parks have suffered vandalism which cost approximately \$2,000.

City Councilor, Matt Ausec: City Council held a public meeting on Costco. The month of January is filled with City Council meetings planning for this year. There will be a meeting on rate increases need for garbage services. They will discuss the topic of a bridge. The Salem City Council has now adopted a Priority Based Budget System. They have designed a way to work better with goals and available money to meet the most critical goals. Everyone is invited to all public meetings the City Council holds. They also have positions available for those that would like to volunteer to be on a committee that has openings.

Josh Graves, Catholic Community Services, to speak on a new program on Early Childhood Development: 3737 Portland Rd. location will be turning a warehouse into 4 classrooms for early childhood kindergarten promise training centers, pediatric dental and medical facility.
