Draft Recommendations and next steps were discussed.

#### **Document wording change:**

"Some individuals engage in behaviors and activities that negatively impact the downtown and business activities."

## 5. <u>DISCUSSION OF RECOMMENDATIONS</u>

**Good Neighbor Partnership:** Establish a downtown good neighbor partnership for those who live, work, shop, and visit downtown Salem that supports appropriate behavior and ongoing dialogue with stakeholders.

Assess Salem codes and ordinances to ensure that the City is appropriately balancing the rights of those who live, work, and shop in our downtown, and providing the City of Salem with the tools they need to address behaviors that negatively impact others. **This recommendation is in conjunction with the Good Neighbor Partnership.**\*

#### **Sit-Lie Ordinance**

Sidewalk camping is a safety issue for the campers and for pedestrians. UGM changed their rules for homeless people downtown and it has helped. Community participation was discussed.

Consensus: assess ordinances. Tie this to the Good Neighbor Partnership.\*

Placing limitations on food distribution Consensus: make no recommendation

### **Challenges & Recommendations Posters:**

Task Force members prioritized recommendations with blue dots for a positive vote, and red dots for a negative vote.

- 1. Showers/toilets/laundry/hygiene -13 blue dots
  - a. Provide a hygiene center with showers and laundry 6 blue dots
- 2. Good neighbor policy with expectations for behavior 12 blue dots
  - a. Assess codes and ordinances to confirm whether or not they meet community needs
    2 red dots
- 3. Safe downtown for everyone
  - a. Endorse a simplified point of contact system 12 blue dots
  - b. Limited options for safely storing possessions during the day 7 blue dots
    - i. Support development of additional storage for homeless individuals....
  - c. Panhandling (rework title and description) 10 red dots
    - i. Alternative ways of giving
  - d. Illegal activities are taking place on downtown sidewalks 10 red dots
    - i. Crime Prevention Through Environmental Design (CPTED)
- 4. Clean-up garbage/human waste
  - a. Expand downtown cleaning services 8 blue dots

## 6. ACTION ON RECOMMENDATIONS

Urban Development Director, Kristin Retherford, will update the recommendations as outlined above and email them to the Taskforce. The Final Draft of Recommendations will be forwarded to the Mayor and City Manager, then to Council.
